May I request you respond to the following:

1. As it relates to the Naval Air Station Kahului Airport (NASKA) Sewage Pump Station Fund (Chapter 3.52, Maui County Code ("MCC")):
  - a. What is the annual cost to maintain and operate the pump station?
  - b. Is there a current agreement between the State and County to ensure the cost of operating and maintaining the pump station continue to be borne by the State?
2. As it relates to the Highway Beautification and Disposal of Abandoned or Derelict Vehicles Revolving Fund (Section 3.25.030, MCC):
  - a. Are the two positions currently filled?
  - b. Explain the increase in disposal charges for \$0 to \$175 per vehicle. If the disposal charge is \$175, why is the County charging only \$50 for administrative fees?


- c. Explain the Junk Vehicle Disposal Assistance program and the amount of funds requested for the program. How many vehicles are processed through this program?
