

SUBJECT: AMENDMEDING THE FISCAL YEAR 2017 BUDGET: EMERGENCY FUND (BF-105)

Thank you for your letter dated February 22, 2017. The Department of Public Works offers the following responses to your request for information:

1. An itemized list of expenses by contract or purchase order number, and include the amount paid and index code used.

An itemized list of expenses is provided in Exhibit "A".

2. A list of Capital Improvement Project appropriations used to address the emergency flood events. Include the current balance of each CIP appropriation.

This list is provided in Exhibit "A".

3. A list of projects that have been delayed since September 2016 because of the lack of funds from depleted appropriations used for the emergency flood work. Include projects such as the South Kihei Road Culvert Replacement.

The following projects have been delayed due to the lack of funds from depleted appropriations used for the Department's emergency response to the September 2016 flood event:

- Emergency Repair of Hauoli Street Drainage Basin and Outlet Repair, Job No. 17-26. An additional \$300,000 is being requested for permitting fees due to the expiration of the Governor's Emergency Proclamation.
- Wakea Avenue and Hoohana Street Drainline, Job No. 17-03.
- Hiolani Street Drainage Improvements, Job No. 16-18.
- Emergency Work at Iao Stream Debris Basin (Phase II), Job No. 17-22.
- Hana Highway Landslide Repairs Near MP 42, Job No. 17-34.
- 4. Explain how your Department will be impacted through the remainder of Fiscal Year 2017 should the funds not be approved.

Several of the above noted projects have environmental permits that are expiring and the costs to reapply for time extensions are substantial. In addition, all of the drainage-related projects address critical flooding issues and to delay them would put the County at risk for potential claims. Each of the projects are either already bid out or ready to be advertised.

The Countywide Drainage funds were utilized to address substantial flooding and drainage issues resulting from the September 2016 flood. This funding source has been depleted and can no longer

sustain additional drainage projects or be used to fund any future unforeseen emergencies relating to drainage. As such, any large sink holes or culvert repairs that are beyond the capacity of our departmental staff will need to be put on hold until a funding source can be identified.
