I am writing to ask you to PLEASE **VOTE YES ON INCLUSION IN PEA-4(1)** of the bill enacting *more stringent enforcement* of the HAWAII BASIC BILL OF RIGHTS FOR VICTIMS AND WITNESSES in the 2018 Maui County Legislative Package.

A recent dangerous and unstable escapee from the Hawaii State mental institution with a murder record was able to get on two planes and leave our state BEFORE the family of the murdered woman and the public were notified. I want you to think about how that would affect you were it your child, parent, aunty, tutu's killer who escaped. Think about the terror, anger, and anguish you would feel hearing this information days after it occurred because *"although we have a state statute for victims rights - HS 801D is not enforced"*.

I want you to think about your son or daughter being raped or murdered - they and you are traumatized beyond words. Yet YOU must continually call for information on your case because NO NOTIFICATIONS ARE SENT OUT BY THE PROSECUTORS OFFICE. It is a state mandate! Yet victims must beg for information!

Hawaii is one of 15 states without a constitutional amendment guaranteeing Victims Rights as set forth in Hawaii Statute 801D. WHY???

Last year, Marsy's Law was presented before our state with over 100 testimonies in favor of the law. The ONLY Prosecutors office in the state that opposed Marsy's Law was Maui County, run by JD Kim. WHY???

A Maui County Council member "suggested" enforcing victims rights would open county employees up to civil litigation and thus would be "irresponsible" of the county. **Irresponsible to uphold the law ??? the state statute???**

If you are employed by the county or State you are entrusted with duties to protect the public, and accountable when a wrong has occurred. It does not impede the system, it makes it run with **TRANSPARENCY, with ACCOUNTABILITY**. It provides a REMEDY.

By not amending HS 801D to enforce victims rights The County is essentially absolving itself of its duties to victims and the public.

*This bill would support the constitutional rights victims and witnesses already have as common citizens.*

Dear Maui County Clerk Maui County Council,

I have snorkeled regularly on Maui for 24 years and have a front row seat to the deterioration of our reefs. I believe the Maui Government should do everything in your power to protect the reefs, including cleaning up the injection well situation which is so damaging to the coastal environment, it is in violation of EPA standards.

I also believe you should be more circumspect about the developments you approve. The monstrous condo development which is being built right on Maluaka Beach (Makena Beach and Golf Resort) is a case in point and I believe the construction site is negatively impacting the reef there. That used to be one of the most vibrant living reefs on Maui.

Please stop the rampant upzoning. Zoning laws are there to protect Maui's natural beauty which is so essential to our economy. Visitors spent \$3.55 billion year to date as of September, 2017 and the economy is dependent on preservation of the environment. I own two vacation rentals and I know visitors love to snorkel. This is something I understand the tourism authority doesn't ask about, but they should.

Banning sunscreen which is toxic to reefs is also a step in the right direction. With the increase in bleaching events arising from global climate change, our reefs need to be as otherwise healthy as possible in order to be resilient. Reefs are also essential to protection of our beaches.

**RE: Opposition to Proposed Oxybenzone and Octinoxate Ordinance**

Chair White:

On behalf of the Personal Care Products Council (the Council), I am writing to express opposition to the proposed local ordinance that seeks to ban the sale and use of personal care products with oxybenzone and octinoxate.

The Council is the leading national trade association representing the cosmetic and personal care products industry. The Council's approximately 600 member companies manufacture and distribute the vast majority of products marketed in the U.S. As the makers of a diverse range of products that consumers rely on daily, from sunscreen, shampoo, and toothpaste to antiperspirant, moisturizer and lipstick, personal care product companies are global leaders committed to safety, quality and innovation.

**Prior to adoption, we believe it is important to assess the legality of the proposed ordinance, especially with regard to jurisdictional authority, federal preemption, and commerce clause implications.** As a threshold matter, there is the question of whether the county has been delegated the authority to regulate consumer behavior allegedly impacting offshore environmental resources. Such authority would seem to be exclusively within the purview of Hawaii's Department of Land and Natural Resources/Division of Aquatic Resources, as set forth under the state's comprehensive and uniform scheme of statutory regulation for this area of law. Likewise, there is the question of whether the ordinances are preempted by the federal Food, Drug and Cosmetic Act, which prohibit states and localities from establishing any provision for nonprescription drugs that is different from or in addition to federal requirements. The purpose of such preemption is to provide "national uniformity" with respect to product manufacturing and composition, labeling, and advertising for nonprescription drugs. Similarly, since most sunscreens are imported into Hawaii from out of state, there are potential commerce clause ramifications with Maui County's proposed ordinances that need to be investigated. Coupled with the logistical difficulty of enforcing the bans proposed by these ordinances, we believe these legal concerns merit a detailed examination before this committee can proceed with adoption.

**The proposed ordinance is not based on proven science, but rather on a single laboratory experiment that lacks sufficient scientific evidence connecting sunscreen ingredients to coral bleaching.** Regulations and legislation should be based on validated methods, reproducible studies, and conducted by more than one independent lab. The laboratory experiment was based on preliminary research conducted under exaggerated laboratory conditions, which do not accurately reflect the complexity of the natural marine environment. According to noted scientists, coral requires an elaborate ecosystem to survive. Transporting coral to an artificial setting alone, such as a laboratory, makes the coral less viable and likely to die in the face of any disturbance. In addition, the data presented by Downs *et al.* (2015) raise questions over the validity and reliability of the study's analytical and toxicological findings.

In a recent news article, Terry Hughes, Director of the Australian Research Council Centre of Excellence for Coral Reef Studies at James Cook University, suggests that extrapolations asserting sunscreen is damaging the world's coral "are a bit of a stretch." He continues, "the conclusion from the media is sunscreen is killing the world's coral, and that's laughable." Another study involving five weeks of chronic exposure to UV filters at concentrations above those reported in natural sea waters reported that sunscreens did not induce coral bleaching nor reduce the photosynthetic efficiency of the symbiotic micro-algae.

The threat to the world's coral reefs is a very serious concern. According to the U.S. National Oceanic and Atmospheric Administration's (NOAA) Coral Reef Conservation Program, coral reefs are impacted by an increasing array of hazards – primarily from global climate change, ocean acidification, and unsustainable fishing practices. Climate change and ocean warming are the most notable culprits for reef bleaching. According to NOAA, coral bleaching events have occurred as the world's oceans temperatures have increased to the warmest levels recorded since measuring began in the late 19th century.

**Sunscreen products are vital to human health. A county-specific restriction on the use of this product would limit consumer choice and ultimately put citizens and tourists visiting the state at great risk.** The U.S. Food and Drug Administration (FDA), the Centers for Disease Control and Prevention (CDC), the U.S. Surgeon General, the American Academy of Dermatology (AAD), the Skin Cancer Foundation and health care professionals worldwide emphasize that using sunscreens is a critical part of a safe sun regimen. The dangers of sun exposure are clear and universally recognized by public health professionals and dermatologists. The National Institutes of Health Report on Carcinogens identifies solar UV radiation as a 'known human carcinogen.' A single bad burn in childhood greatly increases the risk of developing skin cancer later in life.

**Oxybenzone and octinoxate are FDA and internationally approved critical ingredients to the worldwide sunscreen market.** Oxybenzone is a broad spectrum sunscreen, absorbing both UVA and UVB rays, and also photostabilizing other sunscreens to provide long lasting protection. The cost of oxybenzone and octinoxate containing sunscreens is substantially less than other alternative ingredients. In addition to FDA, Health Canada, Australia, the European Union and several ASEAN countries have approved the use of oxybenzone as a safe and effective sunscreen ingredient. **Consumer costs for effective sunscreen products that have the same or similar high SPF levels will increase significantly with no measurable environmental benefit.**

**The claim that octinoxate is an endocrine active is false.** Endocrine activity is well studied, including studies by the National Toxicology Program showing octinoxate is not estrogenic nor androgenic/anti-

androgenic. Further, the safety of octinoxate has been established in studies of reproductive toxicity and teratology. Any of the claims made in the contrary are based upon exaggerated exposures not resembling realistic human exposure.

The proposed ordinance lacks the necessary scientific evidence to demonstrate that this sunscreen ingredient is in any way responsible for coral bleaching. Moreover, skin cancer is the most commonly diagnosed cancer in the United States. If passed, this local law will create confusion, put consumers' health at risk and potentially discourage the use of sunscreens – an important part of a safe sun regimen. **Oxybenzone and octinoxate based sunscreens are affordable daily use products that have excellent skin cancer prevention properties that cannot be easily attained using alternative ingredients.**

We ask that you oppose this legislation. Thank you for your consideration.

Aloha no ia oukou, County Counsel Members/Greetings to all of you.

My name is Kyle Nakanelua and I have been farming taro from 1989. My annual harvest ranged from 8,000 to 15000 pounds a year.

I was prompted to write to all of you by Leina Wender and inform all of you of the infestation of feral hogs in the area of Keanae/Wailua, particularly in the area called Lakini which is on the the Hana Hwy. Up on the ridgeline, above Wailua village. The feral hogs have decimated my taro crop for the past 3 years. In 2015 I caught and killed 32 Hogs. In 2016 I caught and killed 40 Hogs. This year so far I have caught and killed 16, the last one was yesterday. A young female nursing 6 babies. The only reason I have not caught more this year is because they are getting smarter about how they travel and deal with snares. I have seen them observing a hog caught in a snare as if they were studying and accessing the situation. These animals are smart. They will not go away. I have just spent 6 thousand dollars fencing off my farm. It is good for now, until they figure out how to get around it. I do not know what to do, but I sure could use help. Normally in the country, we put our heads down and attend to our work. We work hard at being self reliant and self sufficient. We do not bother people with our trials and tribulations. I heard DLNR had programs on Hawai'i Island that employed UH Hilo Agriculture and Environmental students to trap and eradicate animals. Anything could help.


