In response to your request for information dated February 29, 2024, your request and the corresponding answer(s) are provided below by the Department of Environmental Management (DEM):

1. Provide a breakdown of how the \$7,403,000 appropriation will be used.

Response:

Due to various unknowns in regards to timing, Permanent Disposal Site selection, and number of potential opt-out properties, several assumptions were considered to develop the original below estimates.

Since selecting the Permanent Disposal Site and the continued receipt of residential and commercial right-of-entries (ROEs) by the County, the estimated budget needs for FY24 were revisited. The estimated volume of debris from the alternative debris removal program is estimated to be lower than originally anticipated; therefore, the below table reflects the anticipated budget amendment need for FY24. Also included in the table is the breakdown of funding type for the budget amendment.

Response:

In error, the full description of the original project was utilized as part of the description for the Appendix C project and should not have included the word "operation".

3. Have the temporary site for the alternative debris removal program and the permanent disposal site been selected? If so, please provide the selected site locations. If not, please provide the site locations under consideration and explain when the selections will be made.

Response:

The Department of Environmental Management recently announced the location of the Permanent Disposal Site at the Lahaina community meeting of February 28, 2024. The Central Maui Landfill was selected as the Permanent Disposal Site. The Temporary Disposal Site for the alternative debris removal program will also be located at the Central Maui Landfill.

4. How much of the requested funds is for the design and planning costs the Department incurred for the previously proposed permanent disposal site at Olowalu? Could the design and plans be used for the new site? Why or why not?

Response:

Please see Item 1 in the table above, \$309,000 of the requested funds were incurred for the previously proposed permanent disposal site at Olowalu. The remaining balance was utilized to provide hazardous waste training to landfill personnel and to develop a sampling and analysis plan for testing of ash for commercial properties.

Certain aspects of a design could be re-used, but due to differences in topography, geology, and environmental controls each design is site specific. Depending upon the location of the Permanent Disposal Site at Central Maui Landfill, existing environmental controls may be utilized and the topography and geology are mostly known.
