Chair and Members:

Your Government Relations, Ethics, and Transparency Committee, having met on July 9, 2024, makes reference to Resolution 24-128, entitled “AUTHORIZING A GLOBAL SETTLEMENT OF ALL WILDFIRE LITIGATION AGAINST THE COUNTY OF MAUI COLLECTIVELY.”

Resolution 24-128’s purpose is to authorize a global settlement of all wildfire litigation against the County of Maui, collectively, arising from the August 2023 wildfires on Maui Island, under terms discussed in an executive meeting.

Your Committee is in receipt of a proposed CD1 version of Resolution 24-128, attached to correspondence dated July 8, 2024, from the Corporation Counsel, which was also approved as to form and legality. The proposed CD1 version clarifies that the settlement would apply to claims resulting from the Lahaina and Upcountry wildfires, including crossclaims, counterclaims, and claims yet to be filed under a class certification, and attaches a list of cases filed as of July 8, 2024. The CD1 version also provides that the Corporation Counsel will submit semi-annual reports to the Council identifying any future cases settled under the authority granted by the resolution.

The Corporation Counsel and Special Counsel provided an overview of the claims in open session.

The Corporation Counsel requested an executive meeting to discuss confidential information related to the claims.

Your Committee voted to convene an executive meeting, closed to the public, to consult with legal counsel under Section 92-5(a)(4), Hawaii Revised Statutes, and to deliberate upon a matter that requires the consideration of confidential information under Section 92-5(a)(8), Hawaii Revised Statutes.

Following the executive meeting, your Committee reconvened in regular session.

Based on information received in the executive meeting and the recommendation of the Corporation Counsel and Special Counsel, your Committee voted 6-0 to recommend adoption of Resolution 24-128, CD1. Committee Chair U'u-Hodgins, Vice-Chair Paltin, and members Cook, Lee, Rawlins-Fernandez, and Sugimura voted "aye." Committee members Johnson, Kama, and Sinenci were excused.

Your Government Relations, Ethics, and Transparency Committee RECOMMENDS that Resolution 24-128, CD1, as revised herein and attached hereto, entitled "AUTHORIZING A GLOBAL SETTLEMENT OF ALL WILDFIRE LITIGATION AGAINST THE COUNTY OF MAUI COLLECTIVELY," be ADOPTED.

No. 24-128, CD 1

AUTHORIZING A GLOBAL SETTLEMENT OF ALL WILDFIRE LITIGATION AGAINST THE COUNTY OF MAUI COLLECTIVELY

WHEREAS, in August of 2023, several large wildfires devastated the island of Maui causing significant loss of life and injuries, immense damage to public and private property, and untold economic damage; and

WHEREAS, approximately 451 wildfire lawsuits involving a variety of claims resulting from the Lahaina and Upcountry fires have been filed in the United States District Court and the Hawai'i State Circuit courts as of July 8, 2024 ("Wildfire Litigation") by affected parties ("Plaintiffs"), see attached Exhibit "A"; and

WHEREAS, the County of Maui, Plaintiffs, crossclaimants, counterclaimants, and any other named parties, in any capacity, to avoid incurring expenses and the uncertainty of a judicial determination of the parties' respective rights and liabilities, will attempt to reach a global resolution of the Wildfire Litigation by way of a global negotiated settlement, to include crossclaims and counterclaims as well as claims yet to be filed pursuant to a class certification; and

WHEREAS, the Department of the Corporation Counsel has requested authority to settle the Wildfire Litigation before the Government Relations, Ethics, and Transparency Committee; and

WHEREAS, having reviewed the facts and circumstances regarding the Wildfire Litigation and being advised of attempts to reach resolution of these lawsuits by way of a global negotiated settlement by the Department of the Corporation Counsel, the Council wishes to authorize the settlement; now, therefore,

BE IT RESOLVED by the Council of the County of Maui:

1. That it approves a global settlement of all Wildfire Litigation filed against the County of Maui as of July 8, 2024, including crossclaims, counterclaims, and cases yet to be filed prior to the expiration of the statute of limitations;
2. That it authorizes the Mayor to execute a global Release and Settlement Agreement on behalf of the County in the Wildfire

Litigation, under terms and conditions as may be imposed by the Corporation Counsel consistent with the Council's settlement approval;

3. That it authorizes the Director of Finance of the County of Maui to satisfy settlement of the Wildfire Litigation, under terms and conditions as may be imposed by the Corporation Counsel consistent with the Council's settlement approval;
4. That the Corporation Counsel will submit semi-annual reports to the Council identifying any future cases, beyond the cases listed in Exhibit "A", that are settled under the authority granted by this Resolution. This reporting requirement ceases once the statute of limitations has passed and there are no further cases to be reported; and
5. That certified copies of this Resolution be transmitted to the Mayor, the Director of Finance, and the Corporation Counsel.


