Lucy Feinberg

July 29, 1948 – July 31, 2018



Maui County has lost a hero who dedicated her life to helping our most vulnerable community members for decades. With great sadness we share the shocking news that Lucy passed away on July 31, 2018 at the Lucile Packard Children's Hospital, Stanford University Medical Center in Palo Alto California. Lucy was born on July 29, 1948 in Chicago and raised in Trenton, New Jersey. She attended college at Northeastern University in Boston and has her master's degree in Social Work from the University of Wisconsin, Milwaukee.

Lucy moved to Maui in '86 and became a prominent champion for families affected by

child abuse and neglect, domestic violence, and mental health challenges. She began her long and notable social work career in Milwaukee where she worked with youth at risk. After she moved she served as a supervisor at Child Protective Services in the 1980s, a supervisor at Alternatives to Violence, the long-time administrator of Child and Family Services, and the Regional Director of Parents and Children Together (PACT) until she retired in 2016. Her professional career spanned nearly four decades.

Lucy has been an inspiration to the many staff she supervised as well as colleagues across the social services network throughout Maui County. Since her retirement Lucy has been volunteering her compassionate heart and broad expertise toward positive community change, including: as Chair of the Maui County Children's Justice Committee; with dedicated membership in Organizing for Action; Mom's Demand Action; Maui Peace Action; Maui Nui Botanical Gardens; Hawaii Islands Land Trust and the Sierra Club. Lucy's passions also included visiting her grandchildren Adella and Cole in San Francisco, paddling for the Kihei Canoe Club for over 20 years while serving on the board and racing at many state regattas throughout the Hawaiian Islands. She enjoyed hiking the beautiful mountains of Hawaii, cruising on her OCI in Kihei waters, hanging out in the cool water of Wailuku river and snorkeling.

Lucy is survived by her loving partner, Roy Sabado, her daughter Sierra D. Schwidder and son in law, Bill, who reside in San Francisco with their children Adella and Cole. She is also survived by her elder brother, Rabbi Paul Feinberg and his wife Tania, their children Uri Feinberg, his wife Meryl, their three daughters, Meitav, Shira and Adi; and their daughter Ariella, her husband Gili Shamash and their three boys, Roe, Amit and Idan. Lucy is also survived by her younger sister, Miriam Feinberg Vamosh, her husband Arik Vamosh and their two daughters: Maya, her husband, Yonatan Dubinsky and their children Tamar, Eliah and Noam; Nili, her husband Amichai Yosef and their two children Dan and Hallel. Lucy's brother, sister and their children live in Israel.

Lucy is survived by many friends who considered her family.

A celebration of life will be held at Kihei Canoe Club on September 8, 2018 in the early morning around 8:30 am. Please, if you want to bring flowers for her, bring petals alone - no strings or plastic that could endanger sea life. An Ohana gathering will follow taking her out to sea.
