The FY 2023 Actual amount was \$1,005,865, which is \$499,336 less than the FY 2023 Adopted budget of \$1,505,201. Also in FY 2023, the actual Operations amount was \$417,450, which is \$407,968 less than the adopted Operations amount of \$825,418. Is this a trend that will continue in FYs 2024 and 2025? How much of the FY 2024 adopted Operations amount of \$851,618 has been encumbered or expended, to date? (Page 4-1, Budget Details) (TP)

Response: The Office of the County Auditor must maintain a degree of operational and budgetary independence from both the Executive and Legislative branches.

My requested budget continues to provide that independence by allowing the Office to contract for Audit Services and Professional Services to meet our Charter-mandated responsibilities without relying on budget amendments during the fiscal year.

Further my requested budget provides the Office the flexibility to consider procuring third-party Certified Public Accounting firms for unplanned audits requested by the Mayor and/or the Council. For example, as was requested by the Council in Fiscal Year 2022, my Office contracted a

third-party Certified Public Accounting firm to perform the "Assessment of the Zoning Administration and Enforcement Division, Department of Planning".

Response: The increase will accommodate annual contract increases for the Charter-mandated Financial Audit of the County of Maui. Further, we anticipate incurring additional charges for the Single Audit of federal grants received for the COVID 19 pandemic and the August 2023 Maui Wildfires. These grants will increase the number of major programs to be audited.
