A BILL FOR AN ORDINANCE AMENDING THE FISCAL YEAR 2026 BUDGET, APPENDIX A, PART I, DEPARTMENT OF POLICE, DEPARTMENT OF TRANSPORTATION HIGHWAY SAFETY GRANTS, INCREASE APPROPRIATION BY \$495,000

BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:

SECTION 1. Ordinance 5816, as amended, "Fiscal Year 2026 Budget," Appendix A, Part I, Grants and Restricted Use Revenues– Schedule of Grants and Restricted Use Revenues by Departments and Programs for Fiscal Year 2026, is amended to increase the appropriation for the Department of Police, Department of Transportation Highway Safety Grants, in the amount of \$495,000, to read as follows:


