On behalf of the Department of Environmental Management, I am transmitting a proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING THE FISCAL YEAR 2024 BUDGET FOR THE COUNTY OF MAUI, REVENUES; DEPARTMENT OF FINANCE, COUNTYWIDE COSTS, SUPPLEMENTAL TRANSFER TO THE SOLID WASTE FUND; CAPITAL IMPROVEMENT PROJECTS, DEPARTMENT OF ENVIRONMENTAL MANAGEMENT,

The purpose of the proposed bill is to amend the Fiscal Year ("FY") 2024 Budget by 1) increasing interfund transfers by \$7,304,000, increase Carryover/Savings in the General Fund by \$7,304,000, and adjust Total Estimated Revenues accordingly; 2) amending Department of Finance, Countywide Costs, Supplemental Transfer to the Solid Waste Fund, by increasing Category B - Operations & Equipment in the amount of \$7,304,000 and adjusting the total accordingly; 3) adjusting the Total Operating Appropriations to reflect an increase of \$7,304,000 in Category B – Operations & Equipment and adjusting the total accordingly; 4) amending Capital Improvement Projects, Department of Environmental Management, Countywide, Sanitation, Solid Waste Management Fund, to add a new appropriation entitled "Lāhainā Wildfire Disposal Sites" in the amount of \$7,304,000; 5) amending the Total Capital Improvement Project Appropriations to reflect an increase of \$7,304,000; 6) adjusting the Total Appropriations (Operating and Capital Improvement Projects) accordingly; and 7) amend Appendix C, Department of Environmental Management, West Maui Community Plan Area, to add a new project and project description entitled "Lāhainā Wildfire Disposal Sites" in the amount of \$7,304,000.

These funds will be used for site, plan, design, and operation of a temporary site for the alternative debris removal program and a permanent disposal site related to August 8, 2023 severe weather and Lāhainā Wildfires.
