SUBJECT: A BILL FOR AN ORDINANCE AUTHORIZING THE MAYOR OF THE COUNTY OF MAUI TO ENTER INTO AN INTERGOVERNMENTAL AGREEMENT WITH THE U.S. DEPARTMENT OF AGRICULTURE NATURAL RESOURCES CONSERVATION SERVICE RELATED TO THE KULANIHAKOI STREAM SEDIMENT REMOVAL EMERGENCY WATERSHED PROTECTION PROJECT

The attached bill for an ordinance authorizes the Mayor to enter into an intergovernmental agreement with the U.S. Department of Agriculture Natural Resources Conservation Service to complete the Kulanihakoi Stream Sediment Removal Emergency Watershed Protection Project.

The project will involve removal of sediment and vegetation within Kulanihakoi Stream, between Piilani Highway and South Kihei Road. The drainageway, which is privately owned, has been filled with sediment over the years and requires emergency action to reduce flood risk, loss of life, and damage to adjacent properties.
