A BILL FOR AN ORDINANCE AMENDING THE FISCAL YEAR 2026 BUDGET, OFFICE OF THE MAYOR, ECONOMIC DEVELOPMENT PROGRAM, ECONOMIC DIVERSIFICATION AND DEVELOPMENT INITIATIVE, UPDATING THE CONDITIONAL LANGUAGE FOR THE RISING FROM THE ASHES LLC FOR FILM PRODUCTION TO MANA MAOLI – LĀHAINĀ RISING FOR FILM PRODUCTION

BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:

SECTION 1. Ordinance 5816, as amended, "Fiscal Year 2026 Budget," Section 3.B.12.c.(2).(iv), Office of the Mayor, Economic Development Program, Grants and disbursements for business development and technology, Economic Diversification and Development Initiative, is amended to update the conditional language for Rising from the Ashes LLC for film production to Mana Maoli – Lāhainā Rising for film production, to read as follows:
