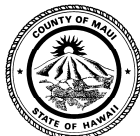

May I please request your response to the following:

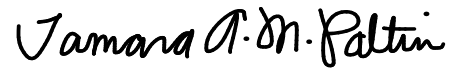

The Maui Emergency Management Agency presents the 2025 update to the County of Maui Hazard Mitigation Plan. The County of Maui Hazard Mitigation Plan represents the County's commitment to reduce risks from natural hazards and serves as a guide for decision makers in committing resources in the effort to reduce the effects of natural hazards. It is in accordance with the federal Robert T. Stafford Disaster Relief and Emergency Assistance Act, as enacted by section 104 of the Disaster Mitigation Act of 2000, Public Law 106-390, that the County of Maui Hazard Mitigation Plan must be updated every five years and in accordance with Title 44 of the Code of Federal Regulations, Section 201.6 ©(5), the County of Maui Hazard Mitigation Plan and any updates thereto must be formally adopted by the governing body of the jurisdiction. Please see the comprehensive update, dated August 2025, attached as Exhibit "1" as we have determined that it is eligible for final approval pending adoption by the Maui County Council.
