Your Government Relations, Ethics, and Transparency Committee, having met on January 26, 2021, makes reference to County Communication 19-29, from Council Chair Kelly T. King, relating to litigation matters.

By correspondence dated November 17, 2020, the Department of the Corporation Counsel requested consideration of a proposed resolution entitled "AUTHORIZING SETTLEMENT OF CLAIM NO. 4067061 OF MAUI ELECTRIC COMPANY, LIMITED."

The purpose of the proposed resolution is to authorize the Department to settle the claim in the amount of \$22,160.10.

The Department also transmitted a copy of the claim and documentation relating to the claim.

Your Committee notes that the Council's Governance, Ethics, and Transparency Committee (2019-2021 Council term) met on December 1, 2020, and December 9, 2020 (reconvened).

Your Committee notes the claimant alleges damages to, and replacement of, a utility pole located at 4899 Lower Kula Road, Kula, Maui, Hawaii, resulting from a collision involving a Maui County fleet vehicle on November 6, 2018.

Your Committee notes Section 3.16.020(B), Maui County Code, requires Council authorization for any settlement of claims or civil litigation in excess of \$7,500.

A Deputy Corporation Counsel provided a brief overview of the claim. He said the incident occurred when a County of Maui refuse truck damaged a utility pole when the vehicle reversed into it.

Based on the information received and the recommendation of the Department, your Committee voted 9-0 to recommend adoption of the proposed resolution. Committee Chair Molina, Vice-Chair Rawlins-Fernandez, and members Johnson, Kama, King, Lee, Paltin, Sinenci, and Sugimura voted "aye."
