Chair and Members:

Your Water and Infrastructure Committee, having met on November 17, 2025, makes reference to Bill 160 (2025), entitled “A BILL FOR AN ORDINANCE AUTHORIZING THE MAYOR TO ENTER INTO AN INTERGOVERNMENTAL AGREEMENT WITH THE CITY AND COUNTY OF HONOLULU BOARD OF WATER SUPPLY, THE COUNTY OF HAWAI‘I DEPARTMENT OF WATER SUPPLY, THE COUNTY OF KAUA‘I DEPARTMENT OF WATER SUPPLY, THE STATE OF HAWAI‘I DEPARTMENT OF LAND AND NATURAL RESOURCES, THE STATE OF HAWAI‘I DEPARTMENT OF AGRICULTURE, AND THE STATE OF HAWAI‘I DEPARTMENT OF HEALTH, FOR THE WAI MAOLI: FRESH WATER INITIATIVE.”

Bill 160’s purpose is to authorize the Mayor to enter into an intergovernmental agreement with various governmental entities on O‘ahu, Kaua‘i, and Hawai‘i Islands for the Wai Maoli: Fresh Water Initiative.

Your Committee notes that the Wai Maoli: Fresh Water Initiative:

- Was established in 2013 by the Hawai‘i Community Foundation to address increasing threats to freshwater security in Hawai‘i;
- Aims to ensure a sustainable, plentiful, and cost-effective freshwater supply for all of Hawaii’s needs; and
- Strengthens Hawai‘i’s long-term water security through coordinated management of freshwater, stormwater, wastewater,

and recycled-water resources; shared climate-resilience planning; and joint exploration of funding opportunities.

Your Committee further notes that under Section 2.20.020, Maui County Code, the Mayor must not enter into any intergovernmental agreement or amendment to an intergovernmental agreement which places a financial obligation on the County or any department or agency, unless authorized by ordinance.

An administrator from the City and County of Honolulu Board of Water Supply explained that the Initiative builds on more than a decade of collaboration among county and State agencies to address water security, conservation, reuse, and climate adaptation.

The Administrator noted that Honolulu’s One Water framework, which received national recognition, has demonstrated the value of breaking down departmental silos and coordinating on projects such as stream restoration, watershed management, stormwater capture, and recycled-water expansion.

Your Committee finds that Bill 160 will strengthen the County’s ability to plan for long-term water resiliency, incorporating proven One Water practices—conservation measures, exploration of recycled water to enhance fire resilience, and ongoing discussions about water rights and management—to promote reliable freshwater supply in Hawai‘i through statewide coordination.

Your Committee voted 7-0 to recommend passage of Bill 160 (2025), on first reading. Committee Chair Cook, Vice-Chair Sugimura, and members Johnson, Lee, Paltin, Sinenci, and U‘u-Hodgins voted “aye.” Committee member Rawlins-Fernandez was excused.

WATER INITIATIVE,” approved as to form and legality by the Department of the Corporation Counsel, incorporating nonsubstantive revisions.

A BILL FOR AN ORDINANCE AUTHORIZING THE MAYOR TO ENTER INTO AN
INTERGOVERNMENTAL AGREEMENT FOR THE WAI MAOLI: FRESH WATER
INITIATIVE

BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:

SECTION 1. The County of Maui Department of Water Supply, the City and County of Honolulu Board of Water Supply, the County of Hawai'i Department of Water Supply, the County of Kaua'i Department of Water Supply, the State of Hawai'i Department of Land and Natural Resources, the State of Hawai'i Department of Agriculture, and the State of Hawai'i Department of Health seek to enter into an intergovernmental agreement for the Wai Maoli: Fresh Water Initiative as described in the Memorandum of Understanding attached as Exhibit "1."

Section 2.20.020, Maui County Code, provides, "Unless authorized by ordinance, the mayor shall not enter into any intergovernmental agreement or any amendment thereto which places a financial obligation upon the county or any department or agency thereof."

SECTION 2. Under Section 2.20.020, Maui County Code, the Council authorizes the Mayor to execute the Memorandum of Understanding and any amendments consistent with the purpose and scope of the Memorandum of

Understanding that do not increase the County's financial obligation or the agreement's duration.

SECTION 3. This Ordinance takes effect on approval.

FRESHWATER INITIATIVE MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding aims to secure Hawai'i's freshwater by sharing expertise in the adoption of a One Water approach tailored to each island's unique needs.

DEFINITIONS:

Members: Signatories of this MOU, County and State entities

Resource Participants: Other contributing individuals, organizations or companies.

BACKGROUND: Fresh water is the foundation of economic and environmental sustainability for Hawai'i, but our supply is increasingly threatened by precipitating factors of climate change and a growing population.

In 2013, the Hawai'i Community Foundation (HCF) launched Wai Maoli: Hawai'i Fresh Water Initiative (FWI) to address water supply issues in Hawai'i. This initiative set ambitious goals for conservation, recharge, and reuse with over 30 recommended policies and changes to be implemented by 2030. Wai Maoli FWI.

The FWI aimed to secure an additional 100 million gallons per day of reliable freshwater for our islands by 2030. HCF brought together diverse stakeholders, including agriculture, private landowners, scientists, and government representatives, collectively, the Members and Resource Participants who developed the Freshwater Blueprint and have contributed to its implementation over the past decade with notable progress. Freshwater Blueprint

HCF's philanthropy organized and supported the FWI for over a decade contributing their leadership, energy and resources, of which the Members and Resource Participants are very appreciative. In return, the Members and Resource Participants express our commitment to extending our collaborative efforts, funding and in-kind services toward the FWI goals.

Over the past decade, a *One-Water* concept has been adopted nationally and used by many states, including Hawai'i. This approach provides an integrated method for planning and implementing the management of finite water resources to ensure long-term resilience and reliability, meeting the needs of both communities and ecosystems.

WHEREAS, water, in all forms, is critical for Hawai'i's natural and built systems and managing it sustainably will be essential as the pressures of growth and development, aging infrastructure, and climate change and sea level rise increase over time; and

WHEREAS, Hawai'ian ahupua'a management acknowledges that all parts of a watershed, from mauka to makai, are interconnected, and activities carried out in one portion of a watershed can affect the rest of the watershed; and

WHEREAS, climate change is creating significant challenges for Hawai'i, including decreasing precipitation trends, increased runoff, erosion, flooding, drought, and saltwater intrusion that threaten ecosystems, water supply, freshwater sources, and agriculture;

WHEREAS, a *One-Water* approach can meet the FWI goals by managing finite water resources through integrated planning and implementation to ensure long-term resilience and reliability for both community and ecosystem needs.

WHEREAS, a *One-Water* approach can create resource and financial efficiencies in the natural and urban water cycles by managing stormwater, wastewater, groundwater, seawater, freshwater, graywater, and recycled water as an integrated resource, including roadways, buildings, parks, trees, treatment plants, pumping stations, and water distribution, drainage and wastewater collection systems.

WHEREAS, Honolulu County has developed it's One Water Honolulu program, providing useful insights for other Counties. A *One-Water* approach can help share information, skills, experience, and collaboration opportunities, enhancing existing financial and human resources by pooling them together and leveraging other sources, while respecting each County's unique resources and conditions.

NOW, THEREFORE, by this document, the Members and Resource Participants listed will work collaboratively to assist in the integrated planning and implementation of *One-Water* projects to meet the FWI goals, while respecting each County's unique resources and conditions. This MOU will assist the parties in identifying resources and opportunities for the achievement of agreed-upon objectives including:

1. Maximize efficiencies, minimize waste, and integrate management of water resources across freshwater, stormwater, and wastewater; and
2. Align key stakeholders to encourage public support in implementing adaptation and climate resilience actions
3. Establish working groups to coordinate on topical areas as needed. These may include climate change adaptation planning, projects and programs, design guidelines and standards, research, or other topical working groups that would be appropriate and useful.

COMMITMENTS:

1. Meetings will be held at agreed locations and intervals, at least quarterly, to discuss programs, projects, and objectives. Honolulu County will chair the meetings for the first year following execution of this MOU. Each year will be hosted by a rotating chair from Members and Resource Participants. Support for the meetings will be provided through a contractor to manage the administrative burden for the chair.
2. Contributions of necessary resources to support a multi-year work plan. This may involve allocating staff time for meeting coordination, pooling resources, shared funding for a long-term coordinator position, and other essential resources or capacities as collectively determined.

3. Seeking opportunities to obtain funding to implement agreed upon objectives, including collectively working on and developing applications for Federal funding and external financing.
4. The Members and Resource Participants will employ a consensus-based approach in making decisions in the interest of maintaining the broadest base of support.

GROUND RULES:

In recognition of the diverse perspectives, experiences, and responsibilities represented in this cross-sector partnership, all parties to this Memorandum of Understanding (MOU) commit to the following principles to guide our interactions and ensure a collaborative, respectful, and productive environment:

1. **Creating a Safe and Inclusive Space**
We commit to fostering an environment where all voices are heard and respected. Each participant should feel comfortable contributing ideas, raising concerns, and sharing perspectives without fear of dismissal or judgment.
2. **Engaging in Open, Candid Dialogue**
We value transparency, curiosity, and the free exchange of ideas. Honest and constructive conversations especially around complex or sensitive topics are essential. We commit to active listening and to addressing challenges directly, with a shared focus on problem-solving and learning.
3. **Removing Institutional Hats**
While we each bring expertise and responsibilities from our respective sectors, we also recognize the value of stepping beyond organizational roles when appropriate. In such moments, we agree to “take off our hats” and engage in person-to-person dialogue to build mutual understanding, strengthen trust, and advance shared goals.
4. **Assuming Positive Intent**
We approach all interactions with a mindset of goodwill and respect. When differences arise, we seek clarification before making assumptions, recognizing that our varied backgrounds may influence how we communicate and interpret information.
5. **Respecting Confidentiality and Trust**
Certain discussions may require discretion to allow for open, strategic dialogue. We agree to respect the confidentiality of those conversations as appropriate, and to protect the integrity of the relationships being built through this partnership. Nothing herein shall be construed to limit the obligations of Members under Hawai‘i’s public records and open meeting laws.
6. **Acknowledging and Embracing Differences**
We recognize the strengths that come from engaging across sectors and cultures. We strive to understand and honor each other’s priorities, constraints, and contributions—working collaboratively to bridge differences and identify common ground.
7. **Committing to Growth and Accountability**
As this partnership evolves, so too will our approach to communication and collaboration. We commit to regularly revisiting these ground rules, welcoming feedback, and holding ourselves and each other accountable to the values and intentions we have outlined here.

MISCELANEOUS CONDITIONS:

1. The Members and Resource Participants may allow additional Resource Participants to join, if such addition is agreed to by consensus of the current Members and Resource Participants.
2. This MOU may be modified at any time by amendment. Amendments to the MOU must be agreed to in writing by all Members and Resource Participants. This MOU shall not modify the existing authority of any Member, nor shall it reduce, expand, or transfer any of the statutory or regulatory authorities or responsibilities of any such Member.
3. Any Member may terminate its participation in this MOU by providing thirty (30) days written notice to all Members.
4. Nothing in the MOU shall be construed as a commitment to providing financial resources in violation of County, State or Federal laws.
5. Members and Resource Participants are not obligated to commit resources, commit use of their lands or participate in obtaining funds unless such commitments are part of a specific and separate written agreement executed by the Member(s) and Resource Participants. Expenditures will be determined by separate and specific written agreements entered by the Members and Resource Participants.
6. This Agreement may be executed in counterparts, utilizing electronic signatures, each of which so executed shall, irrespective of the date of its execution and delivery, be deemed an original and said counterpart together shall constitute one and the same instrument. Copies shall have the same effect as original ink signatures.
