

APPROVING THE APPOINTMENT OF JONATHAN LIKEKE SCHEUER TO THE EAST MAUI REGIONAL COMMUNITY BOARD

WHEREAS, Section 8-19.2(1) of the Revised Charter of the County of Maui (1983), as amended, requires one member of the East Maui Regional Community Board to be a representative of the Hawaiian Homes Commission, recommended by the Department of Hawaiian Home Lands, and approved by the Council; and

WHEREAS, on the East Maui Regional Community Board, Jonathan Likeke Scheuer's two-year term as the Hawaiian Homes Commission's representative expires on March 31, 2025; and

WHEREAS, by correspondence dated January 27, 2025, attached as Exhibit "A," the Chairman of the Hawaiian Homes Commission advised that the Department of Hawaiian Home Lands approved Jonathan Likeke Scheuer to be reappointed as the representative on the East Maui Regional Community Board; and

WHEREAS, Jonathan Likeke Scheuer is not a resident of the County of Maui; and

WHEREAS, Section 2.60.040, Maui County Code, requires that the appointment of a non-county resident must be approved by a resolution approved by a two-thirds vote; now, therefore,


BE IT RESOLVED by the Council of the County of Maui:

1. That, under Charter Section 8-19.2(1) and Code Section 2.60.040, it approves the appointment of Jonathan Likeke Scheuer to the East Maui Regional Community Board as the Hawaiian Homes Commission's representative for a term starting April 1, 2025, and expiring March 31, 2030; and
2. That certified copies of this Resolution be transmitted to Dr. Jonathan Likeke Scheuer, the Mayor, the Managing Director, the Director of the East Maui Water Authority, the
