Chair and Members:

Your Budget and Finance Committee, having met on January 9, 2018, makes reference to County Communication 17-254, from Councilmember Riki Hokama, relating to amendments to Appendix A, Grant Revenue – Schedule of Grants by Departments and Programs for Fiscal Year ("FY") 2018.

By correspondence dated November 29, 2017, the Budget Director transmitted a proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING THE FISCAL YEAR 2018 BUDGET FOR THE COUNTY OF MAUI AS IT PERTAINS TO APPENDIX A, PART I, GRANT REVENUE – SCHEDULE OF GRANTS BY DEPARTMENTS AND PROGRAMS, DEPARTMENT OF FIRE AND PUBLIC SAFETY (STATE OF HAWAII DEPARTMENT OF TRANSPORTATION HIGHWAY SAFETY GRANTS)."

The purpose of the proposed bill is to amend Appendix A, Part I, Grant Revenue – Schedule of Grants by Departments and Programs, FY 2018 Budget, by replacing the existing grant title to accurately reflect the granting agency.

At the request of the Chair of your Committee, the Budget Director transmitted a revised proposed bill, approved as to form and legality, incorporating revisions to the description in Section 1 of the proposed bill and updating the year of the bill to 2018.

A representative of the Department of Fire and Public Safety said the Department will use the grant award of \$17,344.08 to purchase auto extrication equipment to assist in automobile accidents. He said the equipment is critical for incidents that require specialized stabilization equipment for extrication.

The representative explained the amendment to the title of the grant would allow the Department to accept multiple grants relating to the State of Hawaii Department of Transportation Highway Safety Grants. The Department estimated grant revenue of \$50,000 for FY 2018.

A Deputy Corporation Counsel stated the amendment to the grant title would more accurately reflect the granting agency and be consistent with Appendix A, Part I, of the FY 2018 Budget.

The Budget Director said the grant agreement was effective as of October 1, 2017, and the \$17,344.08 in grant funds will be available upon passage of the revised proposed bill.

Your Committee voted 7-0 to recommend passage of the revised proposed bill on first reading. Committee Chair Hokama and members Atay, Carroll, Cochran, Crivello, King, and Sugimura voted "aye." Committee Vice-Chair White and member Guzman were excused.

BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:

SECTION 1.
