Chair and Members:

Your Economic Development and Budget Committee, having met on January 23, 2020, makes reference to County Communication 20-16, from the Budget Director, transmitting a proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING THE FISCAL YEAR 2020 BUDGET FOR THE COUNTY OF MAUI AS IT PERTAINS TO THE OFFICE OF THE MAYOR, ECONOMIC DEVELOPMENT (ENVIRONMENTAL PROTECTION)."

The purpose of the proposed bill is to amend the Fiscal Year ("FY") 2020 Budget by amending Section 3.B.9.c.(6)(i), Office of the Mayor, Economic Development Program, Grants and disbursements for Water and Environmental Resource Protection and Conservation, Environmental Protection, by deleting proviso (2), which reads "Provided, that \$400,000 shall be for the containment and removal of miconia and other invasive species."

Your Committee notes Economic Development and Budget Committee Report 19-49, as amended, states the Committee supported environmental protection in the FY 2020 Budget with funding for several purposes, including funding for "miconia and other invasive plants containment." Thus, the proviso earmarks \$400,000 to the containment of only miconia and other invasive plant species, not invasive animal species.

The Economic Development Director said removing this proviso would allow the use of the funding to be expanded to include invasive animal species like brown tree snakes. However, your Committee opposed using the funding to manage or eradicate axis deer in the County of Maui.

Your Committee expressed a desire for the Council to have a deer or game management policy in place before the Council approves or allows funding to contain axis deer. The Economic Development Director committed to not granting or allowing funding to be used to manage or eradicate axis deer.

Your Committee voted 5-1 to recommend passage of the proposed bill on first reading and filing of the communication. Committee Chair Rawlins-Fernandez and members Lee, Paltin, Sinenci, and Sugimura voted "aye." Committee member Hokama voted "no." Committee Vice-Chair King and members Kama and Molina were excused.

Your Committee is in receipt of a revised proposed bill, approved as to form and legality by the Department of the Corporation Counsel, incorporating nonsubstantive revisions that take into account prior amendments to the FY 2020 Budget.

Your Economic Development and Budget Committee **RECOMMENDS** the following:

1. That Bill _____ (2020), as revised herein and attached hereto, entitled "A BILL FOR AN ORDINANCE AMENDING THE FISCAL YEAR 2020 BUDGET FOR THE COUNTY OF MAUI AS IT PERTAINS TO THE OFFICE OF THE MAYOR, ECONOMIC DEVELOPMENT PROGRAM (ENVIRONMENTAL PROTECTION)," be PASSED ON FIRST READING and be ORDERED TO PRINT; and
2. That County Communication 20-16 be FILED.
