Mahalo for your time I appreciate your consideration.

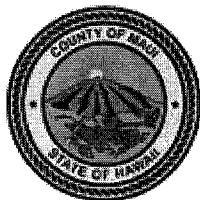

Please don't let this become a stain on Maui's history of environmental stewardship.

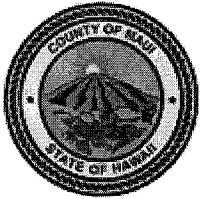
