A BILL FOR AN ORDINANCE NAMING MAPULEHU KULĀIWI

BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:

SECTION 1. Chapter 12.40, Maui County Code is amended by adding a new section to read as follows:

"12.40.320 Mapulehu Kulāiwi. Mapulehu Kulāiwi refers to the area identified as tax map key (2) 5-7-008:076, located at 8303 Kamehameha V Highway, Kaunakakai, Hawai'i."

SECTION 2. New material is underscored. In printing this bill, the County Clerk need not include the underscoring.

SECTION 3. This Ordinance takes effect on approval.
