



PROPOSED FISCAL YEAR 2025 BUDGET

Administration

- Administration has 23 employees
 - \rightarrow 11 vacancies 48%
- County Transient Accommodations Tax
 - > TAT program has 5 of 8 positions vacant 63%
 - Collected approx. \$40.2M in FY22
 - Collected approx. \$85.8M in FY23
 - \geq 10,000+ taxpayers
 - > Approx. 9,772 transactions processed for Q2 FY24



Accounts

- Accounts has 22 employees
 - ➤ 4 vacancies 18%



Real Property Assessment Division

- > RPAD has 44 employees
 - > 5 vacancies 11% (down from 10 last year)
- ➤ Due to reduced vacancies requesting C budget expansion for workstations
- Assisted with Wildfire efforts ROE ownership, RPT waivers, LTR exemptions, maps, data
- ➤ RPAD processed 1,859 wildfire LTR exemptions of which 1,184 were TVR properties and 1,192 were located in Lahaina



Motor Vehicle & Licensing

- ➤ DMVL has 80 employees
 - ➤ 12 vacancies 15%
 - ➤ 6 Kahului Office
 - ➤ 1 Kihei Office
 - > 2 Lahaina
 - > 1 Molokai
 - ➤ 2 Pukalani

- ➤ DMVL has vehicle registration renewal kiosks located at the following locations:
 - > All Safeway stores on Maui
 - County Building Lobby Level
 - Pukalani Foodland
 - > Central Maui Service Center

- > Purchasing has 7 employees
 - > No vacancies



Treasury

- Maui County Service Center Treasury accepts Water, Sewer, and Refuse payments in addition to Real Property Tax.
- The implementation of the EMV card readers proved successful with 87 readers installed in 24 offices.
- In order to increase customer satisfaction, Treasury issued an RFP seeking a vendor to provide an electronic bill presentment and payment solution. The solution will provide mobile, web, IVR, in-person, and kiosk payment opportunities. The vendor was chosen in March 2024.
- Treasury has 18 employees
 - > 3 vacancies 17%
