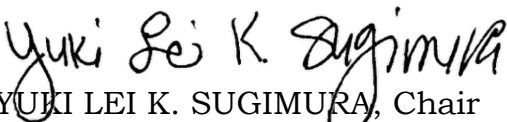

SUBJECT: FISCAL YEAR 2026 BUDGET (BFED-1) (PS-3)

We are in receipt of your communication (BFED-1) (PS-3), which requests answers to several questions. Please find our responses below.

Overall

*Question 1. The following relates to Goal #1, Objective 2: (Page 626, Program Budget)
(TC)(TK)(NUH)*

- a. Please elaborate on what is considered a "recruitment conducted." Does this include a point of contact, interaction, event, etc.? (TC)*

A recruitment conducted consists of:

- Receipt of an approved requisition to fill a vacant position.
- Creating an exam plan and posting the announcement.
- Opening a recruitment soliciting applications to fill one or more vacancies.
- Screening/evaluation of applications received for minimum qualifications.

- This likely involves communicating with applicants (requesting additional information) and the departmental point of contact.
- Depending on the class of work, a recruitment may require a written assessment, training and experience evaluation, and/or a performance/agility test.
- Following the above review, an eligible list of candidates is established.
- The Department of Personnel Services refers the eligible list to the respective department to interview and make a hiring decision.

b. *A success measurement is the number of applications received. In FY 2024, the Department received 8,513 applications. Of those applicants, how many were hired? (TK)*

For FY 2024, there were 704 hires; this number includes 359 seasonal hires for PALS (Seasonal) recreation positions.

c. *The FY 2025 Second Quarter Budget Implementation Report notes that 4,127 applications were received. What percentage of those applications resulted in interviewing or hiring the applicant? (NUH)*

Eligible lists are established, and candidates are added to the list on an ongoing basis as the recruitment continues via the applicant tracking system (ATS). Selected candidates are processed in the Workday system as new hires. There is no efficient way to decipher those who applied in FY 2025 and were hired. 383 employees were hired in FY 2025 as of December 31, 2024. Departments may confirm the number of candidates interviewed and not selected.

Question 2. The following relates to Goal #1, Objective 3: (Page 626, Program Budget) (TK)(SS)(TC)

a. *Which department makes the hiring decision – the department in need of the employee or your Department? (TK)*

Each department head has appointing authority and dismissal for positions included in the department, with the responsibility to interview and make hiring decisions from the list of eligible candidates.

b. *Has your Department's recruitment process been successful with onboarding qualified employees in a timely manner? Explain why or why not. (SS)*

The goal continues to be 90 days and measures several phases in the recruitment process, beginning the date the requisition to fill is approved and ending on the date a selectee is onboarded. Please refer to our response to 1.a.

As referenced in our response to 1.a., this figure also measures the hiring department scheduling, interviewing, conducting reference/background checks, extending a conditional offer, pre-employment drug testing/physical exams, etc., to onboarding the selectee.

- c. *The average time to fill vacancies was 103 days in FY 2024. In FYs 2025 and 2026, it will take an estimated 90 days. Please explain the factors and variables affecting this success measurement. (TC)*

There are a few factors and variables that impact this success measurement. As noted in our response above, there are several phases. Different classes of work may have different post-offer/pre-employment requirements. For example, pre-employment drug testing, physical examinations, background checks, criminal history checks, etc., which adds time to the process from selection to onboarding. The goal is 90 days to fill a vacancy. The FY 2024 average time to fill was 103 days.

- Question 3. *For Goal #1, Objective 4, the FY 2024 Actual is 40 percent. Please explain the high percentage of employees leaving County employment within five years from the date of hire. (Page 626, Program Budget) (TC)*

Of the 193 employees hired between July 1, 2018, to June 30, 2019, 77 employees (40%) are no longer employed by the County. The figure includes college student interns, contract hires, appointed deputies, directors, and other positions from the prior administration, including resignations, terminated staff, and retirees with less than five years of employment with the County.

- Question 4. *The following relates to Goal #2: (Page 626, Program Budget) (NUH)*

- a. *Are the training courses conducted in-person or online, or both? (NUH)*

We host in-person training, hybrid, and online, on-demand training.

- b. *There is a drop in the number of courses offered from FY 2024 to present. Please explain the decrease. (NUH)*

Many of the courses offered are hosted on LinkedIn Learning. It's difficult to predict/estimate the number of courses looking forward. The FY 2025, 2nd quarter YTD is 15,858. This number changes as more trainings are offered.

- c. *Considering that 15,858 training courses were offered as of December 31, 2024, the estimate for training class attendance was 6,000. However, the FY 2025 Second Quarter Budget Implementation Report notes that attendance was 985. How does the Department plan to increase attendance? (NUH)*

Each month, the Department promotes training opportunities to all employees countywide. We also encourage departments to promote training to department staff.

- Question 5. *Under External Factors Description, your Department notes "significant changes in the State and Federal regulatory framework." Please explain changes in State and Federal regulations and its impact to the Department's operations. (Page 622, Program Budget) (TC)*

Changes in State and Federal regulations *may* impact the Department's operations. The emphasis is that we do not have control over external factors that may negatively impact our operations.

Question 6. Which County departments or divisions are engaged with your Department on reorganization? (TP)

The Department of Management reviews and approves reorganizations.

Question 7. Which position descriptions have not yet been updated in the last five years? Ten years? Fifteen years? Twenty years? (TP)

We do not monitor the frequency of position descriptions being updated. Departments are charged with ensuring the accuracy of position descriptions.

"Department of Personnel Services, Administrative Rule 11-206-6 Departmental responsibilities for position classification. (a) Each department shall ensure that the current duties and responsibilities assigned to each of its positions are accurately reflected in an official position description. Redescriptions shall be submitted in a timely basis if significant changes in the duties and responsibilities of a position are made."

Question 8. Is it possible for the Department to use "Core Competencies" instead of, or as an alternative to, minimum qualifications? Please explain and provide a list of pros and cons to these methods. (TP)

Yes, it is possible for the Department to use "Core Competencies" instead of or as an alternative to minimum qualifications. This change would require the various jurisdictions to coordinate the change, as the classification systems are structured with the objective of achieving equal pay for equal work as provided in HRS 76-1, including the minimum qualification requirements. Both approaches—core competencies and minimum qualifications—serve different purposes and can have distinct advantages and drawbacks depending on the context of the position and the goals of the department.

Most minimum qualification requirements provide "a combination of education and experience substantially equivalent to" language. All candidates' education and work experience are evaluated in the broadest and most favorable way to the candidate. Ultimately, the choice between using core competencies and minimum qualifications depends on the department's goals, the nature of the position, and the organization's values. A hybrid approach, where core competencies are paired with essential minimum qualifications, could provide a balanced and flexible framework for selecting candidates. This approach ensures both a baseline of qualification and the potential for assessing how candidates' skills will enable them to perform effectively in the role.

Core Competencies vs. Minimum Qualifications:

Core Competencies refer to a set of skills, behaviors, and abilities that are essential for successful performance in a job. These competencies typically focus on what a person needs to do well on the job and are more dynamic than the specific minimum qualifications traditionally established for the various classes of work.

Minimum Qualifications generally refer to the baseline education, experience, and specific credentials a person must have to be considered for a class of work. These standards are set as specific requirements that ensure candidates meet a certain standard.

Using Core Competencies:

Pros:

- **Flexibility:** Core competencies ideally allow for a broader range of applicants, as candidates may demonstrate skills and qualities that are relevant to the role but might not meet traditional qualifications (such as specific degrees or certifications).
- **Focus on Performance:** Emphasizes the actual abilities and skills required to perform the job, rather than just the background or credentials a candidate may have. This can lead to a more diverse pool of applicants.
- **Adaptability:** Core competencies can be tailored to match the evolving needs of the department or organization, ensuring that the expectations remain relevant over time.
- **Encourages Skill Development:** By focusing on competencies, the department may prioritize training and development, offering current employees the opportunity to build skills that are directly aligned with the department's goals.

Cons:

- **Vagueness:** Core competencies may be seen as too broad or subjective, leading to ambiguity in how applicants are evaluated. It could be difficult to quantify or assess competencies like "communication" or "leadership" objectively.
- **Lack of Standardization:** Since core competencies may vary from one department or position to another, they may lead to inconsistency in hiring practices, making it harder to ensure fairness across the organization resulting in more complaints and appeals.
- **Potential for Bias:** Evaluating core competencies might rely more on subjective interpretation, which could inadvertently introduce bias into the hiring process if not managed properly.

Using Minimum Qualifications:

Pros:

- **Clear and Objective Criteria:** Minimum qualifications set specific, measurable requirements, ensuring that all candidates meet a baseline standard. This makes the hiring process more straightforward and easier to evaluate.
- **Consistency:** Minimum qualifications provide a consistent framework for screening applicants, which can be particularly useful in larger organizations or across multiple departments.

- Legal and Compliance Assurance: Well-defined minimum qualifications help ensure compliance with various laws and regulations regarding fair hiring practices, reducing the risk of legal challenges.

Cons:

- Narrow Candidate Pool: Rigid minimum qualifications may disqualify potentially strong candidates who have relevant experience or skills but do not meet the specific education or certification requirements.
- Limited Flexibility: Minimum qualifications may not account for the varied ways candidates can demonstrate their ability to succeed in a role. For example, someone without a formal degree might still possess the necessary skills gained through experience or informal learning.
- Overlooking Potential: Minimum qualifications may focus too much on past credentials and not enough on a candidate's potential to grow or adapt to the role in the future.

Question 9. The then-Acting Director of Finance last year informed the Committee that their department's Land Management Administrator position description was being worked on with your Department. What is the status of this position? (TP)

The Department of Management approved the Department of Finance's Reorganization on February 24th, 2025. We understand the Department is in consultation with HGEA regarding the department's approved reorganization.

Yes, the County of Maui utilization of EAP services has been trending higher than past years and continued to do so in the FY 2024 and up to the second quarter in FY 2025.

Question 12. The Civil Service Commission met on January 8, 2025, and February 5, 2025, to review your Department's proposed FY 2026 Budget. Did the Commission provide any comments on your Department's budget? If yes, please note their comments. (YLS)

The Civil Service Commission's comments were related to the relatively flat budget. The request for \$300,000 to hire a consultant was a late development, as the initial strategy was to review the Administrative Rules in-house.

Both positions are created and have current position descriptions and are under recruitment.

Yes, an offer was made and accepted with a start date of May 1, 2025. The second position is currently being recruited with the intention to fill it as soon as possible.

Question 1. The following relates to the \$300,000 expansion request under Index Code 908012B-6132, Professional Services: (Page 18-5, Budget Details) (NUH)(YLS)(TP)

a. Please explain the need to hire a consultant for a comprehensive review of existing administrative rules and regulations. How will this improve the Department's efficiency and the filling of vacant positions throughout the County? (NUH)(YLS)

The review of existing administrative rules and regulations was initially considered an in-house initiative. However, the Department currently lacks the bandwidth to take on such an extensive project. We are also mindful that having a fresh perspective from an outside entity may be more beneficial to the County.

The need to hire a consultant for a comprehensive review of existing administrative rules and regulations stems from the necessity to ensure that the Department's operations remain efficient, compliant, and aligned with current best practices. Administrative rules and regulations should evolve over time, and periodic reviews are essential to ensure they are still relevant, effective, and not creating unnecessary obstacles to efficient operations, including the timely filling of vacant positions.

Hiring a consultant for a comprehensive review of the Department's administrative rules and regulations may result in a more streamlined, effective, and legally

compliant operational framework. The efficiency gained from revising these rules will directly impact the speed and effectiveness of filling vacant positions, allowing the County to address staffing needs more promptly and with less complexity. This will contribute to a more responsive, agile, and productive Department, benefitting both current employees and the community it serves.

- b. *What is the process to change the Department's administrative rules and regulations? Would State law need to be amended? (Page 18-5, Budget Details) (TP)*

A public hearing is required to change the Department's administrative rules and regulations. In addition, a comprehensive review of the rules and regulations may reveal areas of HRS 76, and other statutory requirements that may need to be amended to make desired changes.

- c. *Does the Department intend to work with the same entity previously contracted for the retention and recruitment campaign? If yes, please explain why another entity cannot be chosen. (TP)*

No.

- d. *Have retention rates increased since the launch of the retention and recruitment contract? Has recruitment increased due to Federal Layoffs, early termination of the National Dislocated Worker Grant, and businesses destroyed by the August 2023 Maui Wildfires? Please explain. (TP)*

We have made progress in filling vacant positions. Anecdotally, we note an increase in the number of applications along with an increase in the number of recruitments. However, a much deeper evaluation will need to be made and a bit more time before there is confidence to assert that retention rates have increased. In FY 2025, to date, 101 new positions were created, further increasing the vacancy rate.

- e. *The National Association of Counties partnered with WBCP, Inc., to streamline public sector recruitment. Because Maui County is a NACo member, is your Department open to working with WBCP, INC., to conduct a comprehensive review of the Department's existing administrative rules and regulations, and help with the retention and recruitment campaign, including Department reorganizations, updating position descriptions, core competencies, and minimum qualifications? Why or why not? (TP)*

Yes, we are clearly open to learning more about how WBCP, Inc. can assist our Department. The public sector employer is unique and has very specific requirements. Working with a firm that specializes in public sector organizations would be beneficial to understanding best practices, strategies, etc.

Maui News and radio advertisements.

b. Does the Department advertise on the County's social media page as well? (TP)

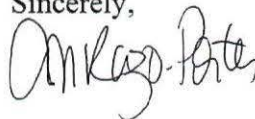
Yes, on LinkedIn, Work Maui Nui and other job boards.
