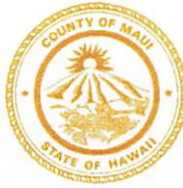

On behalf of the Department of Parks and Recreation, I am transmitting the following:

1. A proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING THE FISCAL YEAR 2022 BUDGET FOR THE COUNTY OF MAUI AS IT PERTAINS TO ESTIMATED REVENUES; DEPARTMENT OF PARKS AND RECREATION, WAILUKU-KAHULUI COMMUNITY PLAN AREA, PARKS AND RECREATION, GENERAL FUND, KEPANIWAI HERITAGE GARDENS IMPROVEMENTS; TOTAL CAPITAL IMPROVEMENTS PROJECT APPROPRIATIONS; TOTAL APPROPRIATIONS (OPERATING AND CAPITAL IMPROVEMENT PROJECTS)."

The purpose of the proposed bill is to amend the FY 2022 Budget by increasing estimated revenues for Carryover/Savings from the General Fund by \$753,027 and appropriating the funds to the Department of Parks and Recreation, Wailuku-Kahului Community Plan Area for the Kepaniwai Heritage Gardens Improvements.

2. A proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING THE FISCAL YEAR 2022 BUDGET FOR THE COUNTY OF MAUI AS IT PERTAINS TO APPENDIX C – CAPITAL IMPROVEMENT PROJECTS, DEPARTMENT OF PARKS AND RECREATION, KEPANIWAI HERITAGE GARDENS IMPROVEMENTS."

The purpose of the proposed bill is to amend Appendix C of the FY 2022 Budget by adding a project and project description for the Kepaniwai Heritage Gardens Improvements.

3. A Certification of Additional Revenues for Carryover/Savings from the General Fund for \$753,027.

The project funding of \$444,519 was included in the FY 2021 Budget and bids opened on October 29, 2021. The lowest qualified bid exceeded the FY 2021 appropriation therefore; additional funds as well as reappropriation of the FY 2021 funds are requested. The additional funding is for the required archaeological monitoring and final report and other related costs to construct the Hawaiian Hale. A copy of the bid results is attached for your reference.

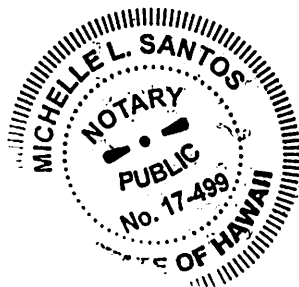


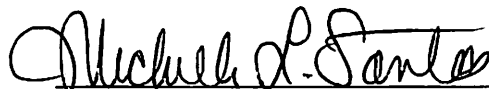

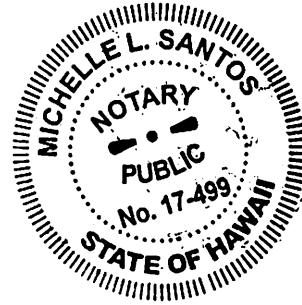
