AS IT PERTAINS TO APPENDIX A, PART I,
GRANTS AND RESTRICTED USE REVENUES - SCHEDULE OF GRANTS AND
RESTRICTED USE REVENUES BY DEPARTMENTS AND PROGRAMS,
OFFICE OF THE COUNTY CLERK
(STATE OF HAWAII, ACT 136, SLH 2019 – IMPLEMENTATION OF ELECTION BY MAIL SYSTEM)

BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:


