Dear Chair White and Councilmembers:

SUBJECT: DEFINITION OF "LOT WIDTH"

"Minimum lot width" is included in the development standards table for many zoning districts. Through experience and research, the Planning Department has determined the current definition of "lot width" produces anomalies and inaccuracies in its application to provisions of the Comprehensive Zoning Ordinance and is unduly confusing.

Pursuant to Sections 8-8.3(6) and 8-8.4 of the Revised Charter of the County of Maui (1983), as amended, I therefore respectfully propose the Council's consideration and passage of the attached proposed bill, "A BILL FOR AN ORDINANCE AMENDING TITLE 19, MAUI COUNTY CODE, TO AMEND THE DEFINITION OF 'LOT WIDTH.'"

The current definition states:

"Lot width" means the least horizontal distance between lot lines measured through the midpoint of the lot. The midpoint shall be construed to be the midpoint between the opposite lot lines, except for flag lots where the stem shall not be considered.

The bill's new definition states:

"Lot width" means the diameter of the largest circle that can be inscribed within the lot lines.

The new definition is based on research of other municipal codes and consultation with Department staff and members of the public. The Maui Planning Commission, Lanai Planning Commission, and Molokai Planning Commission have recommended that the Council pass the bill.

BILL NO. _____ (2018)

A BILL FOR AN ORDINANCE AMENDING TITLE 19.04.040, MAUI COUNTY
CODE, TO AMEND THE DEFINITION OF "LOT WIDTH"

BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:

SECTION 1. Section 19.04.040, Maui County Code, is amended by
amending the definition of "lot width" to read as follows:

"Lot width" means the [least horizontal distance between lot lines
measured through the midpoint of the lot. The midpoint shall be
construed to be the midpoint between the opposite lot lines, except
for flag lots where the stem shall not be considered.] diameter of
the largest circle that can be inscribed within the lot lines."

SECTION 2. Material to be repealed is bracketed. New material is
underscored. In printing this ordinance, the County Clerk need not include the
brackets, the bracketed material, or the underscoring.

SECTION 3. This ordinance shall take effect upon its approval.
