BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:

SECTION 1. Ordinance No. 5657, Bill No. 60, CD1, FD2 (2024), as amended "Fiscal Year 2025 Budget", Appendix A, Part I, Grants and Restricted Use Revenues – Schedule of Grants and Restricted Use Revenues by Departments and Programs for Fiscal Year 2025, Department of Police, is amended to increase the appropriation for Department of Transportation Highway Safety Grants by \$425,000, to read as follows:



This bill proposes to increase the appropriation for Department of Transportation Highway Safety Grants by \$425,000.


