



WHEREAS, the donated 183 pairs of Olukai footwear is donated to provide protective footwear for all ocean safety officers employed in the lifeguard division; and

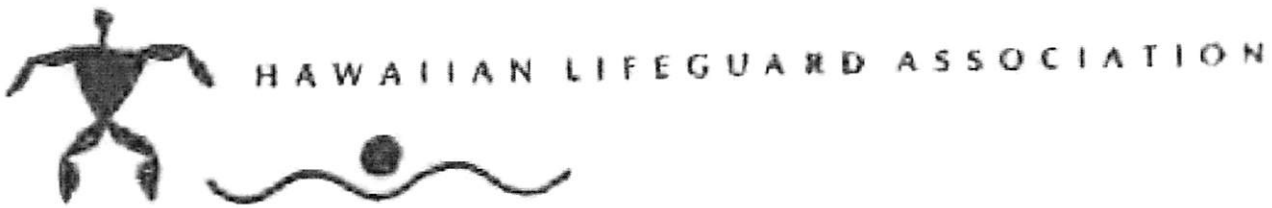
WHEREAS, Chapter 3.56, Maui County Code, authorizes the Council to accept gifts and donations on behalf of the County; now, therefore,


To Whom It May Concern:
