Chair and Members:

Your Government Relations, Ethics, and Transparency Committee, having met on February 6, 2024, makes reference to Resolution 24-15, entitled "APPOINTMENT OF MEMBERS TO THE INDEPENDENT NOMINATION BOARD FOR THE COUNTY OF MAUL."

Resolution 24-15's purpose is to approve or disapprove the Mayor's appointments of Viola Kauakea Diego (Hana) and Kilia Waiomina Ilona Purdy-Avelino (Molokai) as members to the Independent Nomination Board.

By correspondence dated January 29, 2024, the Mayor transmitted completed application forms for the nominees.

Your Committee notes that general appointment procedures for boards, committees, and commissions are outlined in Section 13-2, Revised Charter of the County of Maui (1983), as amended ("Charter"), and Chapter 2.41, Maui County Code.

Your Committee notes that the Maui County electorate, in November 2022, voted to approve the establishment of the Independent Nomination Board commencing in July 2023, to recruit, evaluate, and nominate individuals to serve on boards and commissions established by Charter and by ordinance, and such other offices as specified in the Charter.

Your Committee notes that it previously met on this matter through Committee Report 24-9, which recommended adoption of Resolution 24-1 to approve members to the Independent Nomination Board, with the exception of the Molokai seat, which the Committee recommended be

disapproved, and the East Maui seat, for which the Mayor did not submit a nominee because none of the applications received were from individuals residing in East Maui. At its meeting of January 26, 2024, the Council adopted the recommendations in Committee Report 24-9.

A representative from the Office of the Mayor provided opening comments for each nominee. Your Committee also interviewed both nominees.

Viola Kauakea Diego is the Mayor's nominee for the East Maui residency area. Ms. Diego is a Relief Night Auditor at the Hāna-Maui Resort and a paratransit driver with Maui Economic Opportunity, Inc. Ms. Diego is also a board member for Maui Adult Day Care Centers' Hale Hulu Mamo, Hana Senior Center and previously served as the board president of the Hāna Youth Center, Inc. Characterized by the Mayor's representative as honest and humble, Ms. Diego said she is a student of the Hawaiian language. She believes her knowledge of cultural practices, paired with her care for the well-being of Maui County's kūpuna and keiki will be beneficial to the Independent Nomination Board. Ms. Diego said she plans to nominate individuals to various County seats who have integrity and dependability, and who understand the responsibilities of the positions they hold.

Kilia Waiomina Ilona Purdy-Avelino is the Mayor's nominee for the Molokai residency area. Ms. Purdy-Avelino is a teacher at Kanu o ka 'Āina New Century Public Charter School and a Hawaiian studies and Hawaiian language lecturer at the University of Hawaii Maui College. Ms. Purdy-Avelino previously worked as the Native Hawaiian Library Coordinator for Alu Like, Inc. and served as president of the Hoʻolehua Homesteaders Association, president of Ahupua'a o Molokai, and a board member of Punana Leo o Molokai Hui Makua. Ms. Purdy-Avelino said her family's lineage is tied to Hoʻolehua, Molokai and she knows her community well because of her active involvement in serving its people and 'āina. The Mayor's representative said she is responsible, deeply rooted in her culture, and someone who is passionate about community service.

Ms. Purdy-Avelino said she would like to see members of the native Hawaiian community and generational 'ohana represented in appointed positions in the County.

Your Committee expressed support for the nominees and thanked them for their willingness to serve.

Your Committee recommended approval of Viola Kauakea Diego (East Maui) and Kilia Waiomina Ilona Purdy-Avelino (Molokai) as members to the Independent Nomination Board and amended Resolution 24-15 accordingly.

Your Committee voted 7-0 to recommend adoption of Resolution 24-15, CD1. Committee Chair U'u-Hodgins and members Cook, Johnson, Lee, Rawlins-Fernandez, Sinenci, and Sugimura voted "aye." Committee Vice-Chair Paltin and member Kama were excused.

Your Committee is in receipt of Resolution 24-15, CD1, approved as to form and legality by the Department of the Corporation Counsel, incorporating your Committee's recommended revisions and nonsubstantive revisions.

Your Government Relations, Ethics, and Transparency Committee RECOMMENDS that Resolution 24-15, CD1, as revised herein and attached hereto, entitled "APPOINTMENT OF MEMBERS TO THE INDEPENDENT NOMINATION BOARD FOR THE COUNTY OF MAUI," be ADOPTED.
