7252	Interim County of Maui Greenwaste and Biosolids Management	The current processing area for greenwaste, biosolids, and fats, oils and grease requires relocation for future landfill development, as well as further evaluating processing options. This project will design and construct an interim area to manage greenwaste and biosolids at the Central Maui Landfill.	\$	2,000,000.00	Started
6634	CML Phase II/III Interface Development	The new landfill cell built on the floor of Phase III lays back onto the existing closed landfill slope of Phase II. This work design and installs a Department of Health approved liner system at the lay back slope of Phase II allowing for landfill gas collection and leachate collection and drainage, as well as protection of the slope from the placement and compaction of new municipal solid waste placed onto it.	\$	1,200,000.00	Started
6640	CML Comprehensive EIS	This project complies with the State Land Use Commission Special Permit for Central Maui Landfill which requires the County to apply for a District Boundary Amendment (DBA). An Environmental Impact Statement for the entire proposed district is required for the DBA. This project meets this requirement.	\$	300,000.00	Started
7867	Partial Closures of Active Landfills	The State of Hawaii Department of Health is requiring a demonstration of closure cap effectiveness prior to closing landfill cells. The proposed project will develop test methodology and conduct testing and reporting to satisfy this requirement. 7235	CML Kalialinui Gulch Crossing	The purpose of this project is to explore options for improving the Kalialinui Gulch crossing at the Central Maui Landfill. This crossing is the main connection between Phase IV and Phase III. When filled with water, the gulch runs through culverts under an earthen berm. Stormwater from a large event could cause a washout of the existing crossing cutting off access. The crossing is also part of the site's stormwater management system.	\$	250,000.00	Not Started
3567	CML Land Purchase	The planning phase of this project will provide an appraisal for the acquisition of land to the South of Central Maui Landfill Phase VI. Following future purchase of the land, the property will be permitted and developed to expand the landfill.	\$	2,000,000.00	In Process

WILDFIRE DISASTER EFFORTS / EFFECT ON FY24 BUDGET

Solid Waste Division:

- Design, construct, operate, and close a temporary debris site for temporary containment of wildfire debris from parcel owners opting out of the federal debris removal program
- Design, construct, and operate a permanent disposal site for all non-hazardous wildfire debris that could not be recycled
- Assist with environmental monitoring for wildfire related activities
- An estimated 800 refuse carts burned, will need to be replaced
- Decreased refuse accounts resulting in an estimated reduction of \$420K in revenue
- Estimated 5-7% reduction in tip fees collected at Central Maui Landfill since the wildfire, but appears to be recovering in recent months

- In anticipation of reduced revenue caused by the Maui Wildfires, no increases are being proposed in the SWD's operating budgets
- The SWD's is pushing out its Asset Replacement Strategy to reduce the SWD's budget equipment request
- No rate or fee increases are being requested

- Wastewater Administration Program: Accounting Section, Design and Construction Section, Planning and Permitting Section







WILDFIRE DISASTER EFFORTS

- ► Effected 4 Pump Stations "Temp fix"
 - ▶ Rebuild 2 stations
- Compromised collection system Lots of I&I
 - ► CCTV
 - ▶ Contract repairs
- ► Stabilize Plant Process
 Re-establish process
 - ▶ Work with process experts
 - Prevent non-wastewater dumps



CONTINUING CHALLENGES FACING WWRD



REDUCING ENERGY COSTS

Expected greater energy usage due to additional treatment, facilities and pumping, and cost increases due to rate increases.

Old equipment replaced with higher efficiency models, reducing carbon footprint.



MANPOWER

Replacing retiring employees is problematic and time consuming. Fewer people are applying for County positions. Many applying have little to no experience.
