THE FISCAL YEAR 2023 BUDGET FOR THE COUNTY OF MAUI
AS IT PERTAINS TO ESTIMATED REVENUES;
DEPARTMENT OF PUBLIC WORKS,
COUNTYWIDE, ROAD IMPROVEMENTS, BOND FUND,
COUNTYWIDE FEDERAL AID PROGRAM;
TOTAL CAPITAL IMPROVEMENTS PROJECT APPROPRIATIONS;
TOTAL APPROPRIATIONS (OPERATING AND CAPITAL IMPROVEMENT PROJECTS)

BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:

SECTION 1. Ordinance No. 5392, Bill No. 69, CD1, FD2 (2022), "Fiscal Year 2023 Budget", is hereby amended as it pertains to Section 2, Estimated Revenues, by increasing Bond/Lapsed Bond in the amount of \$3,919,000; and by increasing the Total Estimated Revenues in the amount of \$3,919,000, to read as follows:

This bill proposes to amend Ordinance No. 5392, Bill No. 69, CD1, FD2 (2022), the "Fiscal Year 2023 Budget" of the County of Maui, by amending:

1. Section 2, Estimated Revenues, by increasing Bond/Lapsed Bond in the amount of \$3,919,000; and by increasing the Total Estimated Revenues in the amount of \$3,919,000;
2. Section 4.G.1.c.(2)., Department of Public Works, Countywide, Road Improvements, Bond Fund by adding a project entitled "Countywide Federal Aid Program" in the amount of \$3,919,000;
3. Total Capital Improvement Project Appropriations to reflect an increase of \$3,919,000; and
4. Total Appropriations (Operating and Capital Improvement Projects) to reflect an increase of \$3,919,000.
