Plaintiff, LOU BAFFA, by and through her attorneys, hereby makes the following claims:

PARTIES

- 1. Plaintiff LOU BAFFA is, and at all times relevant hereto was, a resident of the County of Maui.
- 2. Defendant COUNTY OF MAUI is a governmental entity of the State of Hawai'i and is subject to the jurisdiction of this Court.
- 3. Defendant MAUI ELECTRIC COMPANY, LIMITED, is a domestic profit corporation doing

- business in the County of Maui and is subject to the jurisdiction of this Court.
- 4. Plaintiff is presently unable to ascertain the true names of Defendants John Does 1-20, Jane. Does 1-20, Doe Corporations 1-20, Doe Partnerships 1-20, Doe Non-Profit Entities 1-20, and Doe Governmental Entities 1-20 (herein Doe Defendants), who are therefore sued herein under fictitious names. Doe Defendants are connected with the named Defendants; and/or are the agents, servants, employees, representatives, or independent contractors of the named Defendants; and/or were in some manner engaged in the activities alleged herein; and/or were in some manner responsible for the injuries and damages sustained by Plaintiff. Pursuant to Hawai'i Rules of Civil Procedure Rule 17(d), Plaintiff will seek leave of Court to identify and substitute the true names, capacities, and responsibilities of the Doe Defendants when they are ascertained.

JURISDICTION AND VENUE

- 5. The Circuit Court of the Second Circuit, State of Hawaii, has jurisdiction over this matter pursuant to Haw. Rev. Stat. § 603-21.5.
- 6. Venue is proper pursuant to Haw. Rev. Stat. § 603-36(5) because the claim for relief arose in this Circuit.

FACTUAL ALLEGATIONS

7. At all times relevant herein, Defendants, and/or any of them, created, caused, allowed to exist, owned, leased, operated, cleaned, controlled, managed, and/or supervised, failed to inspect and/or maintain its premises, and/or failed to warn about and/or failed to eliminate a condition on the premises which was foreseeably dangerous to members of the public, including Plaintiff,

- which condition created an unreasonable risk of harm to Plaintiff, and was a cause of Plaintiff's injury, on the Front Street sidewalk in front of the Wharf Cinema Center in Lahaina.
- 8. On or about December 29, 2020, Plaintiff was walking on the Front Street sidewalk in front of the Wharf Cinema Center in Lahaina.
- 9. The sidewalk is owned and maintained by Defendant COUNTY OF MAUI.
- 10. There was a recessed area in the sidewalk where Defendant MAUI ELECTRIC COMPANY, LIMITED's utility box was installed.
- 11. Plaintiff's foot was caught by the recessed, vertical section of concrete in the sidewalk.
- 12. Plaintiff fell forward, landing hard on and breaking her knee.
- 13. Plaintiff sustained serious injuries.

LIABILITY

(NEGLIGENCE)

- 14. Plaintiff alleges and incorporates by reference the preceding paragraphs of the Complaint as though fully set forth herein.
- 15. Plaintiff was reasonably anticipated to be on Defendants' sidewalk and utility box.
- 16. Defendants had a duty toward Plaintiff to exercise reasonable care to maintain its sidewalk and utility installations in a safe condition and remove unreasonable risks of harm that arose from the way in which their business was conducted or operated.
- 17. Defendants knew or should have known of the unreasonable risk of harm.
- 18. Defendants had sufficient control over the property to be able to take reasonable steps to remove the unreasonable risk of harm or to give adequate warning of that risk.

19. Defendants failed to take reasonable steps to remove the unreasonable risk of harm or to give

adequate warning of that risk.

20. Additionally, Defendants' mode of operation, specifically their method of allowing the MECO

box to be installed in such a way as to create a tripping hazard in the middle of the sidewalk,

created a condition that posed an unreasonable risk of harm.

21. Defendants' failures and/or mode of operation were a legal cause of injury to Plaintiff.

INJURIES AND DAMAGES

22. As a direct and proximate result of the Defendants' actions, Plaintiff has sustained injuries for

which she is entitled to be compensated, including but not limited to the following:

a. Past, present and future pain and suffering;

b. Past, present and future mental distress and anguish;

c. Health care expenses for past and future treatment related to the above; and

d. Lost wages.

WHEREFORE, Plaintiff respectfully requests the following:

a. That Defendants be found jointly and severally liable for the injuries, damages and losses

described above;

b. That appropriate relief be granted, including awards of general and special damages in

amounts to be proven at trial, along with reasonable attorney's fees and costs, and such

other and further equitable relief as the Court deems just and proper.
