**SUBJECT: TRANSITIONING KALAWAO COUNTY TO MAUI COUNTY (KA'Ā-1(2))**

At its meeting of January 29, 2026, the Council's Kōmike Aloha 'Āina intends to discuss the matter of "TRANSITIONING KALAWAO COUNTY TO MAUI COUNTY."

The purpose of this letter is to confirm, in writing, our understanding of how responsibilities and related expenditures would be allocated if the State Department of Health's proposal to dissolve Kalawao County and incorporate it into the County is enacted by the State Legislature next session.

We have worked with Mayor Richard Bissen and his Administration to review potential County costs related to infrastructure, emergency services, and any other financial obligations the County may incur.

Based on recent discussions, we understand the following:

1. The National Park Service, as the lessee of land from the Department of Hawaiian Home Lands, is and will continue to be responsible for maintaining roads, water and sewer systems, and buildings in Kalawao County.
2. The County will not assume any maintenance responsibilities within Kalawao County.

3. The County will continue its current Memorandum of Agreement with the National Park Service to provide police and fire support.
4. Under the proposed legislation, the County will extend its authority to Kalawao County for activity within the Special Management Area.

May I further request you confirm, in writing, whether this understanding is accurate or identify any corrections or additions, if not.
