

Introduction

William Spence is a degreed, professional land-use planner who has practiced in Maui County for more than 30 years. He has held the offices of Planning Director and Director of Housing and Human Concerns for Maui County and has practiced as a private consultant. He has appeared hundreds of times before the Maui County Council, Planning Commissions, and various boards and agencies.

Professional Experience

William Spence & Associates. April 2019 to Present

My goal as a consultant is to represent clients in obtaining discretionary and legislative approvals through the Maui County Council, planning commissions, and various agencies. A normal course of my services is to make presentations to approving bodies and meet with neighbors or community groups. I also work well and directly with other professionals such as attorneys, engineers, architects, and archaeologists. I represented the first builders to obtain approval under Maui's new §2.97 "fast track" workforce housing law.

Director of Housing and Human Concerns. July 2018 to April 2019

As the first Housing Director with a working knowledge of the entitlement and development processes, I initiated projects to:

- Use affordable housing funds for feasibility studies to build homes on county-owned properties.
- Implement the mayor's administrative "fast-track" permitting program to prioritize ministerial permits for affordable projects.
- Reviewed and promoted affordable and workforce housing projects before the Maui County Council.
- Work with numerous nonprofits toward providing services to Maui's less fortunate population.

Planning Director, January 2011 to July 2018

For seven and one-half years I held the office of Planning Director for Maui County. During that time, I staffed or oversaw staffing for Maui County Council committees, three planning commissions, as well as hundreds of proposals for development and discretionary approvals. During my tenure I accomplished several important projects and performed

- Initiated the re-write of the Special Management Area rules to reduce permitting and clarify vague and inconsistent policies.
- Was qualified many times as an expert witness before the State Land Use Commission.
- Collaborated with Corporation Counsel as a witness in litigation or other legal proceedings.

- Completed an audit of our 50-year-old zoning code and obtained a \$500,000 budget from the Maui County Council to completely rewrite it.
- Appeared before members of the State Senate and House in support of legislation.
- Established a new division within the Planning Department to implement the policies and actions of the Maui Island Plan and community plans.

Planning Consultant, 2002 to 2011

As an independent consultant, my focus was to help small and medium-sized landowners to obtain discretionary or legislative approvals. The types of approvals ranged from simple assessments, bed-and-breakfast operations, to large subdivisions, condominium projects, and changes of zoning.

My responsibilities in obtaining approvals included working with community associations, neighbors, and working collaboratively with other technical disciplines. I made frequent presentations to the Maui Planning Commission and the County Council.

Staff Planner, 1992 to 2002

During my ten years as a staff planner within the Maui Planning Department, I participated in virtually every type of permit and legislative action identified in the County Code. I was the lead planner for special projects such as the community plan revisions and mass rezonings. All involved multiple presentations and hearings before public-interest groups, advisory committees, the planning commissions, and the Maui County Council.

Edwin T. Misaki January 4, 1956

Edwin T. Misaki is a born and raised 3rd generation resident of Molokai. "Ed" grew up as a typical "local boy" actively engaged in hunting, fishing, surfing, playing baseball and basketball. Today, Ed remains active in hunting, fishing, playing softball, basketball, volleyball, golfing and canoe paddling. Ed has also been involved with coaching youth basketball and baseball.

As Director of Moloka'i Programs for The Nature Conservancy of Hawai'i (TNCH) Ed is responsible for overseeing all activities on three Molokai TNC preserves as well as being the main coordinator for the East Molokai Watershed Partnership (EMoWP). Ed has played a big role in establishing the TNCH Moloka'i office and has been a presence for conservation on the island for the past 22 years. First hired in 1983 as Kamakou Preserve Manager, Ed has assumed increasing responsibility as the Moloka'i Preserves Manager, and now as Director of Molokai Programs. In 2003, the Molokai Program hosted an Efroymson Fellows Facilitator training workshop, which Ed attended. During 2004, Ed participated in the Micronesian Efroymson Fellows workshop as a trainee facilitator.

Ed's first objective as a TNCH employee was to developed and established The Kamakou Preserve as the first Nature Conservancy managed preserve in Hawai'i. Additionally, he assisted with the acquisition of the Conservancy's two other Moloka'i preserves, Pelekunu Valley and Mo'omomi. He has been active in developing conservation protocols and tools throughout the state, and continues to work with communities on important conservation issues on Moloka'i. As part of a one year sabbatical in 1997-98, Ed was instrumental in organizing dryland forest revegetation work for the Ka Hula Piko project, an important cultural project on Moloka'i. Ed is currently focuses his time on the East Molokai Watershed Partnership, formed in 1999. The partnership became a reality through Ed's involvement with a community effort through the USDA's Empowerment Zone Application process. Ke Aupuni Lokahi is a community board that governs the USDA's Empowerment Zone (Molokai designated as an "Enterprise Community") programs. Ed has been a board member since 1998.

Ed received his Bachelor of Science degree in Biological Science from Colorado State University. Ed also is a lecturer for the Maui Community College Molokai Education Center, where he teaches the four credit "BIOL 105 Hawaiian Field Biology" course. Ed approaches the lecture as a great opportunity to past on his natural history knowledge about Molokai to his Molokai community peers. Normally, this course would require a Master's degree to teach, but because of Ed's extensive conservation experience, his background was substituted in lieu of a Master's degree.

- ♦ 1997 Ed was Awarded a Sabbatical by TNC to improve his skills working with community and cultural people and projects. During that period, Ed had an opportunity to visit Palau and Ponphei to experience the types of community outreach programs in traditional areas of Micronesia.

My top choice is the Maui Planning Commission because I want to help tackle some of Maui's biggest challenges—our housing crisis, limited water resources, and much-needed infrastructure improvements. Working in civil engineering on Maui has opened my eyes to the unique obstacles we face in managing sustainable, affordable development. I'm passionate about ensuring our resources go towards affordable homes for local residents. I've been working on temporary housing projects in the aftermath of the Lahaina and Kula fires, and in doing so have become frustrated by disaster capitalism and want to play a role in making sure Maui continues to put people before profits. I'd love to work with others who share these goals to make sure we're shaping a sustainable future for Maui.

I'm also interested in the Urban Design Review Board, which would give me a chance to support Maui's development on a more visual and community-oriented level. I believe that design plays a key role in building a sense of place and respecting the culture of our island.
