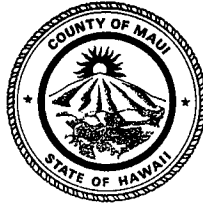

WHEREAS, by correspondence dated May 3, 2018, Mayor Alan M. Arakawa notified the Council that he nominated Jo-Ann Ridao to the Maui Redevelopment Agency for a term expiring March 31, 2019, to fill a vacancy replacing Jonathan Starr, pursuant to Section 2.40.50, Maui County Code ("MCC"), Section 13-2, Revised Charter of the County of Maui (1983), as amended, ("Charter"), and Section 53-2, Hawaii Revised Statutes ("HRS"); and


WHEREAS, Section 53-2 of the HRS requires the Mayor's nominee to be approved by the Council; and

WHEREAS, Charter Section 13-2(17), requires the Council to approve or disapprove the nomination within sixty days after the Mayor submits the name of the nominee to the Council because of the death, resignation, or removal of a member; now, therefore,

BE IT RESOLVED by the Council of the County of Maui:

1. That it approves the appointment of Jo-Ann Ridao to serve on the Maui Redevelopment Agency for a term expiring March 31, 2019; and
2. That the Council expresses its gratitude and appreciation to Jo-Ann Ridao for her willingness to be considered for public service and actively participate in County government; and
3. That certified copies of this Resolution be transmitted to the Mayor, the Managing Director, and the Corporation Counsel.
