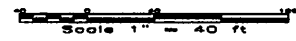
VICINITY MAP

The County of Maui is not responsible for any part, roadway, easement (including, but not limited to drainage, sewer, access, railroad water or irrigation easements), or any other interest in real property shown on this map or shown on these plans, unless the County of Maui has accepted its dedication by a resolution approved by a majority of council members at a regular or special meeting of the Maui County Council or the County of Maui has signed its acceptance via a conveyance document recorded in the Bureau of Conveyances of the State of Hawaii in compliance with Maui County Code Section 3.44.015.
 6. Lot 17-D is a 10 foot wide road widening lot to be owned by Lot 17-C, and will be dedicated to the County of Maui upon demand.
 7. Lot 17-E is a road widening lot to be dedicated to the County of Maui.
 8. The parcel being subdivided contains the following designations: State Land Use Rural, Community Plan Rural, County Zoning Rural (conditional), and Flood Zone X.
 9. The 100 Year Flood Inundation Limits were calculated by Wayne L. Arnold, Professional Engineer of 1827 Newport Street, Hahaione Hawaii 96735.
 10. Denotes no vehicular access permitted.
