BILL NO. _____ (2020)

A BILL FOR AN ORDINANCE AMENDING SECTION 6.08.010, MAUI COUNTY
CODE, RELATING TO ANIMALS AT LARGE

BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:

SECTION 1. Section 6.08.010, Maui County Code, is amended to read as follows:

“6.08.010 Definitions. For the purpose of this chapter, the following words and terms are defined:

A. “Animals” means [cattle, horses, mules, asses, swine, sheep and goats] ungulates.

B. “At large” means off the premises of the owner or custodian of the animal and not under the immediate control of the owner or custodian.

C. “Lawful fence” means a fence as defined in section 142-61 of the Hawaii Revised Statutes.”

SECTION 2. Material to be repealed is bracketed. New material is underscored. In printing this bill, the County Clerk need not include the brackets, the bracketed material, or the underscoring.

SECTION 3. This Ordinance takes effect upon its approval.
