A BILL FOR AN ORDINANCE NAMING HĀMĀKUALOA KULĀIWI

BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:

SECTION 1. Chapter 12.40, Maui County Code is amended by adding a new section to read as follows:

"12.40.330 Hāmākualoa Kulāiwi. Hāmākualoa Kulāiwi refers to the area identified as tax map keys (2) 2-7-007:079, (2) 2-7-007:005, (2) 2-7-007:081, (2) 2-7-007:082, and (2) 2-7-007:083, located at Ha'ikū Sugar East Subdivision, lots 1, 3, 4, 5, 6, Hawai'i."

SECTION 2. New material is underscored. In printing this bill, the County Clerk need not include the underscoring.

SECTION 3. This Ordinance takes effect on approval.
