Thank for your correspondence dated April 17, 2025. We offer the following response to your question.

1. May I please request you explain whether the Special Management Area Revolving Fund can be used to survey or resurvey properties, including obtaining a Geographic Information System overlay?

Yes, the Special Management Area (SMA) Revolving Fund may be used to cover the costs of a property survey or resurvey, including obtaining a Geographic Information System (GIS) overlay, but only under specific conditions. According to Subsection 3.49.020(A) of the Maui County Code, the use of this fund is restricted to three defined purposes. Therefore, the survey or resurvey, along with any GIS work, must be directly related to one of the following:

- 1) Augment enforcement of chapter 205A, Hawai'i Revised Statutes, and special management area and shoreline rules of the Lanai, Maui, and Molokai planning commissions;
- 2) Land and easement acquisition for beach access;
- 3) Master planning, studies, permitting, and implementation pertaining to coastal realignment, beach and shoreline management, beach or dune restoration, or managed retreat.

If the intended survey or GIS overlay does not directly support one of the above purposes, then the SMA Revolving Fund cannot be used for that activity.

Please note the Department does not currently administer a grant management program for the Special Management Area Revolving Fund. Implementing any similar new program would require significant administrative infrastructure to ensure proper application review, compliance monitoring and financial reporting to protect public funds. At this time, the Department does not have the staffing capacity to support those functions while maintaining focus on our core responsibilities.
