Aloha Committee Chair Keani N.W. Rawlins-Fernandez and Economic Development and Budget Committee Members.

I am writing in favor of fair and reasonable tax rates for the vacation rental industry which I fully support.

Short Term Rentals are currently taxed at \$9.28/\$1000, the third highest only exceeded by Hotel and Resort and Time Share rates. Increasing the Short term rental rate too extreme puts an unfair burden on the individual owners of these properties, and the guests to these properties, and can only move to harm the small businesses that depend on the vacation rental industry. The legally permitted Short term rental property owners should not be punished with higher tax rates while lower rates are being proposed for the illegal, unpermitted operations, whose properties are taxed in the Agriculture, Residential and Apartment tax classifications.

We have a blossoming vacation rental industry on Maui, subject to appropriate restrictions and standards, and a fair existing permitting and taxing process. Short term rentals already comprise 25% of the \$319,516,547 of real property tax revenue compared to 11% for time share, and 7% for hotel and resort. The purpose of the industry is to allow for varied accommodations and experiences for visitors, and to allow small businesses to benefit from tourism.

I am supportive of the Economic Development and Budget Committee Committees efforts to find a fair and equitable solution for taxing the vacation rental industry that limits any negative implications for the community. Right now short term rentals brings in \$79,500,00 in direct taxable revenue, and has created thousands of jobs for our island as well.

Our typical guests are families with several children. Similar to our family who have been vacationing in Maui several times a year for the last 20 years, as our children got older, the price of 3 Grand Wailea Rooms for our 4 children along with my husband and I, was too much so we opted to purchase our home in Wailea Beach Villas. Unfortunately, if the higher taxes you are considering are passed, there will be many owners, like myself who will no longer be able to rent our properties as the economics will no longer make sense for guests to pay those taxes and absorbing that increase is not a viable option for us to absorb. We choose Maui because we love it, but would need to look for other island options that are more welcoming to short term rentals for families who spend a lot of money on food, entertainment and activities in Maui.

Thank you for considering my testimony and I hope you will think about it as you continue to craft this bill.

Dear Chair Rawlins-Fernandez, Vice-Chair King and Members of the Economic Development and Budget Committee,

We appreciate the opportunity to provide testimony.

We understand that a new budget process is being used this year in an effort to streamline the process. Watching this morning, it was nice to hear each of the members review their top 5 priorities and concerns. We also understood that Department Directors would not be interviewed, but instead written communication could go back and forth and/or Department Directors could "monitor" the process and then reach out to the Council to provide any clarifications that they felt were needed. In regards to that new practice, we wanted to share our thoughts and concerns we have heard for your consideration, including:

- By asking the Departments to monitor the budget process instead of scheduling a specific time for each of them that they can set aside on their calendar, it requires that individuals take time away from their important work to monitor the entire process as bits and pieces of information on Departments are spread throughout many discussions. This seems inefficient with the potential to cause delays for other work. Instead, having Directors come before you at a specific time provides the opportunity where they can answer all of your questions at one time for all to hear. Further, by having Departments monitor budget discussions and submit other information in writing as needed and as they hear concerns leads to a disjointed presentation of pertinent information.
- Being a Council Member is a very tough job and takes a lot of learning. There are
 several freshman Council Members this year who may not fully understand the process
 or the right questions to ask. Therefore, direct conversations with Department Heads
 may be the most efficient way to ensure everyone is on the same page, the right
 questions are being asked and to understand the nuances of the budget process,
 including bonds and project parameters, so the Council can make informed decisions
 on any adjustments being considered.

- In going back and forth by writing, a lot can be lost in translation. Oftentimes, having an
 in-person dialogue is more effective than writing. With dialogue, questions and answers
 can be better explained, context can be provided and more discussion can be had.
- This new procedure is making it more difficult for the public to stay informed. In the past, the public could easily watch videos of budget hearings online to hear questions asked of Department Directors, their answers and the dialogue in one cohesive session. By only having written correspondence, the public is forced to do more time-consuming research watching many videos to get bits and pieces of conversation, trying to find written documents online to get the full picture and may not get the context and nuances. Given this, the process feels less transparent and inefficient.

We hope you will see the value to the Council and public in taking the time to interview each Director so your many important questions can be asked and answered efficiently and from the individuals who will be charged with carrying forward the community's work.

I go to MNBG at least or	nce a year and I walk a portion of the perimeter of the garden daily. I love the quiet atmosphere

of the garden and I appreciate that the plants are identified as Indigenous, Endemic, or Non-Native(including the

origins), along with the plant's scientific name.

Learning about our Native plants gives me a better understanding of the history of our land and people. It helps me remember and appreciate the rare plants we have in Hawai'i - some that do not exist anywhere else in the world! It also inspires me to learn more about those who came before us and their use of our plants - including preventing illness, as necessary adornments in our cultural practices, and providing shelter and clothing for our people. Over the years, I have participated in a Kapa-making workshop, a kapa-dyeing workshop, and I have attended a lei-making workshop where we made lei to remember our veterans on Memorial Day with the staff of Kaunoa Senior Center. I have interacted with the staff of MNBG. They are knowledgeable and energetic in perpetuating our culture by sharing with residents and visitors the value of protecting and encouraging the proliferation of Native plants in our fragile environment. Maui Nui Botanical Gardens is a benefit to me as a person born and raised in Hawai'i, as a hula dancer, as a person who likes to create images of our Native plants, and as someone who cares deeply about our environment.

MNBG provides a place for students of botany and Hawaiian culture to learn plant identification and experiment with traditional uses. They host more than 1,500 Maui students each year in educational activities that teach native Hawaiian plants and their uses.

Additionally, through its own efforts, MNBG consistently more than doubles the funding provided by the County.

For these many reasons, I strongly urge Council to approve the Mayor's budget request for MNBG.
