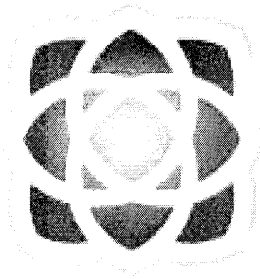

We appreciate the opportunity to provide testimony on the appointment of the Department Directors proposed by Mayor Victorino. Mayor Victorino went through a blue-ribbon committee who vetted and thoroughly reviewed candidates for his department head positions and we support the full slate of directors put forth.
