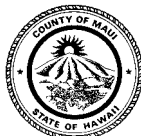

SUBJECT: **MAUI'S LONG-TERM RECOVERY OPERATIONS**
(DRIP-9(4))

At its meeting of June 17, 2026, the Council's Disaster Recovery, International Affairs, and Planning Committee discussed Maui's long-term recovery operations, including recovery efforts from the 2026 Kona Low storms.

During the storms, the stormwater basins for the Kai La'i Ola and Kilohana temporary housing projects reached capacity. The County had to pump out water and issue evacuation warnings to residents in Leiali'i and Wahikuli, prompting flood risk concerns. It was also noted that the property owner received a grading violation.

May I please request the following:

1. Please provide a status update on the stormwater basins for Kai La'i Ola and Kilohana.
2. Please confirm if and when a grading violation was issued, if the property owner responded to the violation, and if there are any proposed remedies to prevent future flood risks.
