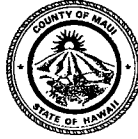

LEGISLATIVE ATTORNEY IN THE OFFICE OF COUNCIL SERVICES


