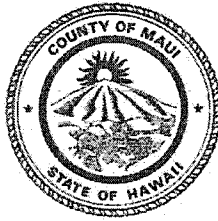

**SUBJECT: EXISTING STREETS (PSLU-49)**

The Department of Public Works is in receipt of your correspondence dated January 23, 2020 in which you request "a cost estimate of exempted improvements to existing streets for all two developable lot subdivisions as described in Maui County Code, Section 18.20.040." Your correspondence further requests a response be transmitted no later than February 6, 2020.

The Department kindly requests additional time to respond with the information being requested as this information is not readily available. Each subdivision file will need to be analyzed to determine the scope of improvement that would have been required if no exemption existed and then appropriate cost factor for each type of improvement need to be determined before a total cost of improvement can be generated for each subdivision. This analysis is not routinely done by our staff and it will require additional effort to ascertain this information.
