Dear Chair Crivello and Committee Members,

Mahalo piha for your committed support of affordable housing and Na Hale O Maui's unique Community Land Trust (CLT) model. We are very appreciative of the financial support we have received from the County of Maui Affordable Housing Fund.

We are flattered that the proposed amendments to Section 2.96 of the County Code related to Workforce and Affordable Housing contain certain features of the CLT model. Workforce and Affordable housing effects not just nonprofit organizations that create housing; they affect so many of our essential workers in Maui County, including but not limited to teachers, firemen, life guards, police, county and private employees.

Hawai'i continues to experience the dire effects of a tremendous shortage of affordable housing and its impact on island families and local communities. We can all agree that the only way to have a serious impact on this housing deficit is to deliver more affordable housing, sooner rather than later. The best, most efficient and effective way to do so is by allowing all the nonprofits engaged in creating homes to have access to the Affordable Housing Fund.

We realize that there is no 'one size fits all' in the development of housing. We need to take advantage of all available avenues to reach our housing goals, including all available nonprofit and for profit developers. There are many pathways to reach our community objective of more affordable housing.

A number of nonprofit organizations currently work diligently to provide affordable rental and for-sale units, including but not limited to Habitat for Humanity, Lokahi Pacific, Hale Mahaolu and Na Hale O Maui. Each nonprofit addresses the need of their clients in different income categories. Each nonprofit requires access to the Affordable Housing Fund in order to carry out its mission to create affordable housing for Maui families.

Habitat for Humanity Maui (Habitat) sells homes to low income families at a no interest and no profit basis, serving families that are between 25% and 80% of the Area Median Income (AMI) for Maui County

Lokahi Pacific develops and maintains affordable and special needs rentals and for sale projects. Their families are income qualified up to 120% of AMI although the majority of their families earn less 100% of AMI.

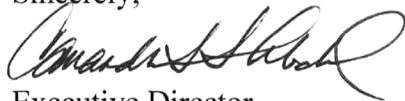
Hale Mahaolu serves the elderly and other special needs people of Maui earning less than 60% of AMI.

Na Hale O Maui's mission is "To secure and preserve a permanent supply of affordable housing alternatives for low and moderate income households in Maui County." Our 501 (c) 3 nonprofit status, allows NHOM to work with families earning less than 140% of AMI due to the high cost of living and housing. We focus on families earning between 80-120% of AMI.

We respectfully request, all good intentions notwithstanding, that access to the Affordable Housing Fund not be limited in order to avoid the unintended consequences of reducing the number of affordable homes. We recognize that together the nonprofit developers are better able to deliver more affordable housing across a broad spectrum of need for island families.

We look forward to continued opportunities to collaborate with the County of Maui and each other, to develop better, more effective and efficient methods to provide affordable housing for our island families.
