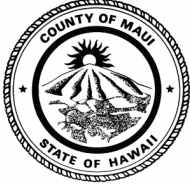

REVIVING THE NĀULU CLOUD BRIDGE (ADEPT-1(11))

Description: Under Rule 7(B) of the Rules of the Council, the Committee may hold a limited meeting and on-site inspection of Kaho'olawe that is not open to the public under Section 92-3.1(a), Hawai'i Revised Statutes, and discuss reviving the Nāulu Cloud Bridge.

Status: The Committee may hold a limited meeting and site inspection of various restoration areas on the upland slopes of Kaho'olawe under Section 92-3.1(a), Hawai'i Revised Statutes, guided by Michael Nāho'opi'i, Executive Director, Kaho'olawe Island Reserve Commission. The Committee may discuss reviving the Nāulu Cloud Bridge, including restoration and reforestation plans to encourage rainfall from leeward Haleakalā to Kaho'olawe. The Committee may also discuss other related matters. No oral testimony or legislative action will be taken.
