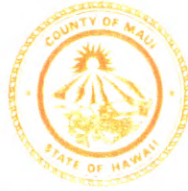

WHEREAS, by correspondence dated April 29, 2019, Mayor Michael P. Victorino notified the Council that he nominated Lorraine Sablas to the Maui Planning Commission for a term expiring March 31, 2023, to fill a vacancy replacing Alalani Hill, pursuant to Sections 2.28.010 and 2.28.070, Maui County Code ("MCC"), and Sections 8-8.4 and 13-2, Revised Charter of the County of Maui (1983), as amended, ("Charter"); and


WHEREAS, Section 13-2, Charter, requires the Mayor's nominee to be approved by the Council; and

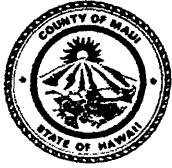
