**Description:** The Committee is in receipt of Resolution 25-215, entitled "PROPOSING AMENDMENTS TO THE CHARTER OF THE COUNTY OF MAUI (1983), AS AMENDED, RELATED TO THE NOTICE AND CONDUCT OF PUBLIC MEETINGS, PURSUANT TO THE HAWAII SUNSHINE LAW." Resolution 25-215's purpose is to place on the next General Election ballot the question of whether the Revised Charter of the County of Maui (1983), as amended, should be amended effective January 1, 2027, to clarify that Council, board, and commission meetings must be publicly noticed and held in compliance with state law by eliminating the outdated requirement to publish notice in a newspaper of general circulation in the County and replacing the term "public hearing" with "public meeting."

Resolution 25-216's purpose is to place on the next General Election ballot the question of whether the Revised Charter of the County of Maui (1983), as amended, should be amended, effective January 1, 2027, to standardize the deadlines related to the Office of the County Clerk's processing of petitions on voter initiative, recall of elected officers or board and commission members, and charter amendments.

**Description:** The Committee is in receipt of Resolution 25-217, entitled “PROPOSING AMENDMENTS TO THE CHARTER OF THE COUNTY OF MAUI (1983), AS AMENDED, RELATED TO COMPUTATION OF TIME.” Resolution 25-217’s purpose is to place on the next General Election ballot the question of whether the Revised Charter of the County of Maui (1983), as amended, should be amended effective January 1, 2027, to specify that the time in which an action must be done is computed by excluding the first day and including the last, unless the last day is a Saturday, Sunday, or holiday, and then it is also excluded.

Resolution 26-11's purpose is to place on the next General Election ballot the question of whether the Revised Charter of the County of Maui (1983), as amended, should be amended effective January 2, 2027, to require a special election to fill a council vacancy if the unexpired term of office is six months or more and, if the unexpired term is less than six months, to remove the time limit for the council to unilaterally appoint a person to fill the vacancy.

Resolution 26-85's purpose is to place on the next General Election ballot the question of whether the Revised Charter of the County of Maui (1983), as amended, should be amended effective upon passage, by removing the English translation of the Hawaii State motto in the Maui County Charter Preamble, allowing the original phrase, "Ua mau ke ea o ka 'āina i ka pono," to stand on its own.
