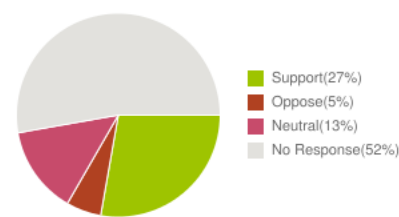

#### Overall Sentiment

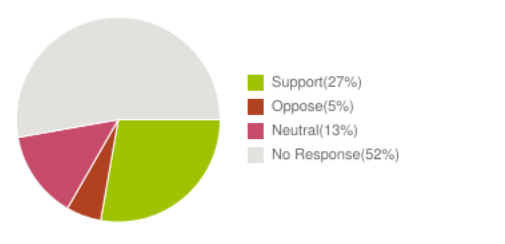

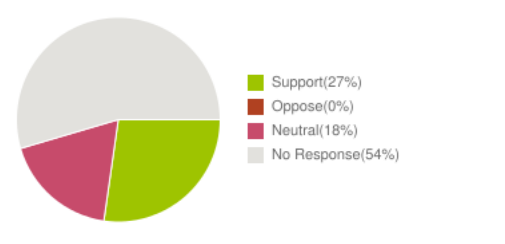

My partner and I are/were a small business owners in Lahaina whose livelihood was destroyed in the fires. The lack of support, by which we mean NONE, for small business owners is appalling. We are more than 7 weeks from the fire and we have received ZERO assistance because we were fortunate enough to not lose our home. At this point, we are beginning to wonder if we would be better off if we had. The only available assistance appears to be SBA, which has also proven to be unhelpful so far. Without any assistance, we will be forced to leave the island. We can't imagine we are not alone in this situation. How does the county, state, or federal government expect to support tourism if there is no assistance for the small business that were lost in the fires? We were like to return servicing our community, but at this rate, not only do we not have funds to rebuild/restart our business, but we are not even receiving support to live now that our livelihood it gone.

2. There are policies adapted by states who are prone to fires, e. g. California. Let us not be too proud and insist that we don't care how they do it in the Mainland. Let's review and adapt best policies.
3. Let's not do the recovery piece meal. With all the monetary resources, let's hire a large professional firm who is in the business of rebuilding and have the resources to do so. Of course, we should be mindful of the input of residents but let's ask the help of professionals to draw up a master plan, have them collate all input, come up with a readjusted plan and execute. Let's not depend on semi-pros who will not follow through or show up for the job. Otherwise, rebuilding will take a century.

5. Listen to the Native Hawaiians. Restore the water pond or whatever else their elders say. They know the course of nature for centuries and progress should not change that, otherwise, more disaster will befall us.
6. I was not directly affected by the fire but my heart is broken as well. We have been residents for more than 30 years and have hopefully given back to the community as best we can. We have volunteered and contributed in our own little way and still do. Please let us know exactly what happened that day, who was in charge, where were our leaders, what went wrong, how are we going to correct it moving forward and what are the consequences to those who failed us.
7. The people of the Westside refuse to be 2nd rate citizens any longer. We need a satellite hospital here. Friends have not survived the 45 min drive (at best) to the other side.
8. Honoapiilani Hwy on a couple of spots is always wet due to the water from the ocean. It won't be long until the ocean will take over, especially on high tide. It is time to move the road onto higher ground instead of waiting for a disaster to happen again.
9. The community has come together in unbelievable ways. We are so lucky to be living in a community such as ours. All we ask is for our leaders be honest with us. It was August. People go on vacation. It's ok to be away from one's job but someone has to be left in charge. It's not ok to think- oh nothing will happen anyways .
10. I am willing to assist in doing research for any project that will need an extra pair of hands.

I am Kanani Higbee, Maui 'oiwi. I am displaced from Lahaina. I would like Hawaiian homes Leialii 1B built asap. Fast track. If developers can get the county and state to approve fast track of HHFDC housing, they can fast track Hawaiian Homes. We waited long enough. 3 generations of my family have died on the list. We still have not gotten a home. In fact, my grandma and sister were murdered. My grandma was murdered for her home up Lahainaluna Road. Many of my family have been murdered when I speak up about Hawaiian homes. Now my home in Lahaina is burned down. Other people received word to leave their homes because of approaching fires and no one warned me and my neighbors. My neighbors perished.

I believe lots of affordable housing need to be built. Not just rentals, but homes for Native Hawaiians to live in. We are under represented in home ownership, over represented in poverty. It's no wonder when we are murdered for

our housing and land.

We need temporary housing in Lahaina and West Maui to be slapped together until our housing is rebuilt. There is not enough being done to rebuild temporary homes.

I would like for us to have steel electric poles that won't knock over when we have strong winds or cars run into them.

We need more water going to Lahaina. We need to not have golf courses anymore. There is nothing Hawaiian about golf courses. That just steals water from our Native Hawaiian farmers in the valleys.

We need other things like a siren that tells us what's the specific emergency. We need lots of fliers and ads in social media and the news telling us what the different siren sounds mean so we know what emergency is happening.

Please, we need homes. We need the land cleaned ASAP so we can go back. There needs to be much more people admitted to their homes with more National Guard dispatched to Lahaina so we can go back to our homes and then begin the next phase.

Please, we are going to be homeless if we don't have Hawaiian homes built. It's genocide for us to wait for years for housing. I was already forced from Maui to California when my sister and grandma were murdered. We need our Native Hawaiian people protected as we fight for our rights. The United Nations need to know that genocide is happening to Hawaiians. Every time I fight for funds for Hawaiian homes, people like Keeaumoku Kapu and his son in law Kaipo Kekona steal our funds to use for projects they want that's not even related to Hawaiian homes. People like myself put my life on the line telling my story of murders that happened to my family so we can get funds for our housing and then greedy people like Keeaumoku Kapu's son in law Kaipo Kekona steal the money. He doesn't need \$20 million for upcountry fencing. He just wants to pocket the money or get others the funds so they can gift him in other ways to his non profit which they use on themselves. It's greedy. Pure greed. Kaipo Kekona gets upcountry funds for fencing from taking from Hawaiians waiting on the list of Hawaiian homes so his family of developers can get bids to build and make a ton of money. We aren't blind to what's happening.

I support the initiative to put the power lines underground. To me it is not right that the federal government bails out Maui Electric and provides funds for them to put the power poles back. That money should be used to put the lines underground. It shouldn't even go to a huge corporation like that when thousands of people are struggling, still having to pay mortgage on a home that is no longer even there. I think there needs to be more support for these families and solutions for them to build quickly so the issue can be resolved.

I also support bringing back Malu Ulu O Lele. We have been talking about managed retreat for years and this is the opportunity to do something. The state went through putting together a comprehensive sea level rise assessment. Use that assessment to set new setbacks in Lahaina so we are not battling for the next 20 years. This is a pivotal moment in Lahaina's history. We need to do things right and with intention. I am writing to submit my testimony in support of a crucial initiative that aims to improve emergency evacuation routes for the Lahainaluna area by utilizing existing pathways along Kahoma Stream. I believe that this proposal aligns with the priorities outlined in the Hawaii Bicycle Plan of 2003 and can significantly enhance the safety and resilience of our community.

Specifically, I would like to refer back to the priority items identified in the Hawaii Bicycle Plan 2003, which

categorized the Kahoma Stream pathway and the Lahainaluna Road as priority II items. It's worth noting that these priorities were carried over from the 1974 Hawaii Bicycle Plan, underscoring their long-standing importance.

The proposed emergency evacuation route along Kahoma Stream has the potential to serve a dual purpose by not only facilitating bicycle transportation but also providing a safe and efficient means of escape during emergencies. Given Lahainaluna's vulnerability to various natural disasters, having such a resource in place is of paramount importance for the well-being of our residents.

The Kahoma Stream pathway, running parallel to the ditch, offers an excellent opportunity to create a dedicated evacuation route. It not only leverages existing infrastructure but also minimizes environmental impact, making it a sustainable choice for enhancing our community's resilience.

Furthermore, the connection between Honoapiilani Highway and Lahainaluna High School via the Kahoma Stream pathway (Item 71 Lahainaluna Road) and the link between Nohea Kai Drive and Lahainaluna High School through the Kahoma Stream pathway (Item 72 Kahoma Stream Path) would contribute significantly to the overall accessibility of the evacuation route network.

I kindly urge decision-makers and relevant authorities to consider the adoption of this proposal as a priority project for the Lahainaluna area. Enhancing our emergency evacuation routes is an investment in the safety and well-being of our community, and it aligns with established priorities in the Hawaii Bicycle Plan. I believe that this initiative will not only improve our readiness for emergencies but also promote sustainable transportation and community resilience.

My name is Elise Travis and I am a 44YR. resident of Maui. I am appalled how the animal rescue was handled by MHS. Top animal rescuers came on their own donations, brought all the top equipment for rescue and wanted to offer their services free of charge and work with anyone to help in the fire zone. They were told explicitly by MHS they were not invited and told if they are anywhere near the fire zone they will be arrested. No Aloha, No thanks for wanting to help. Very cold. MHS was adamant about this and these were the top rescuers who were deployed in Ukraine twice last year saving animals. They were treated horribly. We have all the documents to show this. I would like transparency and would like to know how much the rescuers who were allowed to be in charge were pd. From what I heard they have been pd. a lot of money (\$200,000+) Also, they were not allowed to be in contact with the group hired and not allowed to be connected to work with anyone else. So, many lies were spread to keep them out. We need an investigation into this. This group that was denied clearance also had hazmat training and the drones to go in at night and get the job done fast. I am outraged that this was allowed to happen and the way they were treated when all they wanted to do was to help save the cats in the fire zone. No money needed to pay for their services. Also, the group that was contracted by MHS had no fire experience with fire cats along with the people held in charge. They are only trappers and no training to how to deal and trap the fire cats. They had one photo op and left. They did nothing and got pd. a fortune. I would like transparency as to what they were pd. Also, why they spread the lies to turn people against this group. All documented. Also, would like transparency on the donations collected for the Fire Cats and Animals. This money needs to go for them alone. They cannot be put back into the fire zone like MHS is doing. MHS needs to open sanctuary's with the 3+ mil \$ they collected. This money needs to be earmarked for the well being of the firecats. That's what the donations were for. They can't just release them back into the fire zone. Right now, they will be spraying bad chemicals that will kill any cats left in the zone that are suffering and not being saved. We need the top professional rescuers to come in before they do any spraying. The ones that are hired do not know what they are doing. They are not trained to rescue Fire cats. This is a very specific type of training and it needs to be done now! there is no more time to waste. The Colony Cats were all affected by the fires and by law they are required to take care of them also. No food was allowed to be given to The Colony cats when MHS was giving out food. I was told explicitly by one of the volunteers that food was only given out to Pet Owners. By law they were required to also give food for the Colony cats that were in the Fire Zone and affected by the Fires. This was not done also. We need to get to the bottom of everything that was done and show transparency. Too many people are upset over the debocking of the animal

Aloha Government Relations, Ethics, and Transparency Committee. I apologize for this late testimony but only heard about this meeting a few minutes ago.

As a local Hawaiian, I am looking forward to our island's rebuild. There are so many of us who have lost everything to these fires and are still in shock over what we have experienced.

I'm grateful to the good people and agencies who are helping us with necessary supplies such as shelter, food and other support. Having lived my life on Maui, it's not surprising to see the aloha spirit within the intentions and actions of so many people. "Everyone coming together to help" is how all the best things have always gotten accomplished.

With that said, something feels different this time. The fires have wreaked their havoc on all our lives and while plans are forthcoming to rebuild, my Hawaiian brothers and sisters are feeling lost in the bureaucratic shuffle. Offers of supplies have been abundant but our hearts are absolutely broken.

And to make matters worse for us, our pets are being ignored. We have heard about all the animals still trapped inside the fenced off areas where the fires were. The Maui Humane Society, to put it plainly, has been a joke. For every social media post they make about a family being reunited with their missing pet, there are dozens more agonizing stories of animals that could have been helped, but weren't. examples of them dropping the ball. They told us that they searched for our pets inside the burn zone, but then we learned that by "search" that means a person drove by our burned down homes - without getting out of their vehicle. Of course a scared animal is going to be hiding, not just sitting calmly out front! And once our "Lost" Tickets were closed, the Humane Society's search for our pet concluded. Without having access to search for ourselves, we were counting on the Humane Society to really try. I'm certain that if they did, many more animals would have survived. Apparently it's an issue of space to house them once they catch them. But isn't that the idea of a fire rescue? To Rescue? Was there no plan in place? And why not?

On a positive note, some animal rescuers not associated with the Humane Society have done amazing work. There have been several instances where they trapped a cat and were able to reunite it with its owner. This is the true spirit of aloha. And even though they asked the Humane Society to share some of their donated traps, cages, and food, they were denied. But they keep on going! The unpaid rescuers out there as much as they can be, saving the lives of the animals that the Humane Society fails to.

Please allow the rescuers into the fenced in areas to continue to save the animals trapped in there. From what I understand the Humane Society only has a couple of people in there.

I respectfully ask that you do much more to support and rescue the approximately 500 surviving animals in the restricted area. You must allow more trappers who have the necessary experience and training into the restricted area as there is absolutely no way that the current 2-4 people can trap, monitor trail camera footage and maintain 80 food and water stations.

A mass trapping project must be allowed to take place immediately. Once the EPA begins spraying Soiltac it will result in the death of many more animals and the ones that manage to survive that will unlikely survive the demolition.

Secure the facilities necessary to house these animals. MHS has received more than enough financial assistance from the public to do this. And, as you know, FEMA will also pay for these short term facilities so there is absolutely no excuse for not securing necessary shelter space.

You have plenty of qualified local people who want to assist these animals by feeding, trapping and helping in any way that is needed. Let the community help!

Bring HAKA back! They are the most qualified, well rounded group that has been there at any point since the fire. The current director of field operations for MHS has no disaster response experience. Trapping after a disaster requires special skills that are unknown by those who specialize in Trap Neuter Release. At the very least, HAKA and anyone they approve should be working the restricted area. Ideally HAKA should also be placed in charge of field operations.

People have tried to be incredibly patient through six weeks of egos and posturing as animals suffer and die daily but time has run out!



Hundreds of these animals have families who are desperate to find them but you continue to compound their grief. This must change immediately! The eyes of the world are on Maui and the lack of official concern for the animals. It's time to step up and do the right thing! If you think this can't have a negative impact on both your political careers as well as how the world views Maui in the future then you need to look into Hurricane Katrina and a little dog named Snowball. It's still all over the internet after 18 years!

### **OUR PETS ARE STILL TRAPPED INSIDE THE BURN ZONE!**

It has been confirmed by the Maui Humane Society that there are at least 500 animals still alive and trapped inside the burn zone, an area that's 3 and a half to 5 square miles. They are only using 4 people to trap surviving animals, while dozens of disaster-trained rescuers and expert trappers are being excluded from helping. They have been offered disaster relief help from all over the world but have refused assistance.

It has become sadly apparent that the Maui Humane Society is either not interested in helping the rest of the animals stuck inside the fenced-in burn zone, or are simply inept.

Initially they turned away fire survivor's pets because they claimed that they didn't have the space to take them in. But when presented with the opportunity to open an animal recovery center, they dragged out the process. Once they were forced by the community to do so, the facility was at capacity with rescued and fire-victim animals within days. The Maui Humane Society clearly needs to open more animal recovery centers but once again, are stalling the process.

They have had plenty of time and resources to open a second recovery center but once the demolition process begins, they won't have to. All surviving animals will be crushed or suffocated by bulldozers and hardening spray chemicals.

Animals that have managed to survive this long, need our help and our voice. They are fenced inside the burn zone and will suffer horrific deaths if not rescued soon. We are begging for their lives.

Council Members,

It is as if there is no one in charge. No one has stood up and said, "I am the top leader and the buck stops here! I will get substantive answers for you! Or I will resign because I'm only a distraction at this point and woefully unqualified to lead."

The days of fluffy words, fluffy actions and fluffy expectations are gone. This is life and death at this point, literally, sadly. Infrastructure and proper security that cares about the people, needs to be addressed fundamentally.

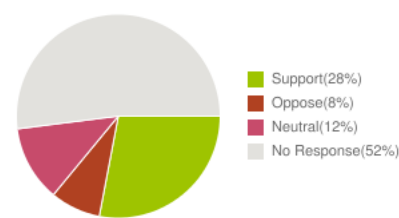

Aloha Maui Council members,

With all the suggestions presented yesterday, we did not see anything about priority building permits for residents. With the shortage of materials and labor, it would be nice for residents to get their permits first. Vacation rentals contribute to the tax base for sure, however with so many displaced residents, it would make a substantial difference if all the resident permits were approved before even reviewing the vacation rental applications. We hope any "Emergency" permitting process prioritized residents over investment properties. Once all the residents have all received their permits, only then begin to review all the vacation rental building permit applications. Even revised resident permits we hope will be prioritized over mainland and foreign real estate investor permit applications.

Of course a moratorium on ALL TVR's would go a long way to helping residents find a medium term home until we can rebuild our homes. Including the invisible grandfathered in units that do not show up on the county site. Is there anyway to have them all listed? Maybe they get guaranteed TVR permits, but we can actually see how many there are. We know in our community TVRs are grandfathered in, however we have no way of knowing if it really is a TVR as we cannot find any info on them. We try and review the Minotoya List, it is difficult. If the county could keep this actual list, maybe cross checking with the GET or TAT. We just cannot tell who is doing a legal TVR vs renting to "Friends". Please find a way to make a comprehensive listing of all TVR in the county please.

We are looking forward to rebuilding as soon as we get our permits approved, get materials on island and find a great group of people to build it. We are making modifications to the old design for ADA access. We hope this does not delay to process too much. We are right on the southern edge of the destruction. We lost everything.

Subject: Urgent Request for Investigation and Action Regarding Recent Tragic Events in Lahaina

Dear Members of the County Council Government Relations, Ethics, and Transparency Committee, I hope this letter finds you well. I am writing to express my deep concern and distress over the recent events that have unfolded in Lahaina, particularly the tragic loss of over 100 lives and the displacement of over 7,000 individuals due to a devastating incident. These events have had a profound impact on our community, and we must take immediate steps to ensure that such a catastrophe never occurs again.

The Maui Fire Prevention Bureau plays a critical role in safeguarding our community from fire hazards and promoting public safety. Their core responsibilities include:

1. Education: The Fire Prevention Bureau is responsible for developing and implementing programs that increase public awareness of fire safety. This encompasses educating the community about fire risks and preventive measures.
2. Enforcement: Code enforcement is a vital function of the bureau, focusing on the enforcement of fire codes and regulations. This includes inspections, investigation of complaints, and ensuring compliance with fire safety standards.
3. Prevention: Fire prevention is at the heart of the bureau's mission. They are tasked with abating fire and life-safety hazards before they can cause injury and property damage.

In May 2022, I initiated correspondence with the Fire Prevention Bureau regarding my concerns about fire prevention and safety in our community. I outlined the need for proactive measures, such as press releases and public service announcements, to engage the community in fire prevention efforts. I did so under the assumption that these requests aligned with the bureau's core responsibilities.

However, despite my efforts to bring attention to potential hazards and the importance of prevention, I received responses that indicated a lack of resources and insufficient action. These emails serve as evidence of my attempts to address the issue and the responses received from the Fire Prevention Bureau.

The tragic events that have befallen our community in Lahaina are a stark reminder of the consequences of inaction and inadequate allocation of resources when it comes to fire prevention and safety. The loss of over 100 lives and the displacement of thousands underscore the urgency of ensuring that the bureau fulfills its basic responsibilities.

I kindly request that your committee:

1. Initiate a thorough investigation into the circumstances surrounding these events, with a specific focus on the actions (or lack thereof) taken by the Maui Fire Prevention Bureau in response to concerns raised by community members.
2. Evaluate the adequacy of resources allocated to the Fire Prevention Bureau and other relevant agencies responsible for ensuring public safety and fire prevention on Maui.
3. Recommend necessary policy changes, resource allocations, or personnel adjustments to prevent similar incidents from occurring in the future.
4. Ensure transparency throughout the investigative process and actively engage with affected community members to provide updates and gather additional information.

In addition to my correspondence with the Fire Prevention Bureau, I also escalated my concerns to various offices within the county government, including the Office of Climate Change, Resiliency, and Sustainability, the Mayor's office, and the Mayor's PR communication department. I requested a public announcement to educate the Maui community about fire prevention. Unfortunately, no action was taken in response to these requests. The loss of over 100 lives and the displacement of thousands in our community are tragedies that should never have happened. We owe it to the victims and their families to thoroughly investigate the circumstances surrounding these events and take swift and effective action to prevent such disasters in the future.

I appreciate your attention to this matter and your commitment to the safety and well-being of our community. I am ready and willing to provide any further information or assistance that may aid in your investigation.

Thank you for your prompt and earnest consideration of this urgent request.

I loved Maui before and despite what has happened I TRULY see now and understand what the real meaning of Ohana is.

With that, I would like to take one minute of my time for silence to remember our Ohana who perished in the August 8 fires as well as take this time to grieve in the silence to represent the mourning that we EACH feel in our heart.

With my last two minutes I am going to give you an outsider perspective. Which an outsider I am. I landed here on October 30, 2008 which a corporate job that brought me here from Texas. Immediately after stepping into the breezeway to get off the airplane, I felt a sense of peace I will never forget. I believe that peace was a peace telling me I was home.

Three months after that I was beat up by two local women for mistakenly cutting them off on the H-2 highway in Oahu while I was there on business. I was literally chased off the road, and yelled at "to go back home back to where I came from you Haole; you do not belong here".

Despite that set back and even a few others my first year, by the end of 2009 I knew even STILL that I was right where I was meant to be. Literally ALL THE ROADS OF MY LIFE led me here, and indeed if you knew my story



you would agree! Fast forward to 2023, after the fires I was given an opportunity to pack it up and move to Texas, where we Betsill's are from. Same with the pandemic in 2020. I could have left and gone down the easy SELFISH road but I stayed because I love Hawaii so much.

Fast forward to now. This is my home and I refuse to live here any longer and not be a part of the solution(s). For many years I was a part of the problem. Running around like a chicken with my head cut off for almost a decade having owned three wedding and event planning businesses, as well as two rental company businesses with my husband. I was busy. I was not paying attention. I was not helping. I was living here benefiting from the land, our Aina, and not giving back the way I should. After this tragedy in Lahaina town though and knowing myself over 36 families that lost their homes I simply refuse to live here anymore and not be a part of the solution!

So with that, I have a question for you. Will you accept me as an "outsider"? Will you allow me the honor to come into this County and State to help make forward progress change that protects the interests of Hawaii nei and many of you in this room? This is not rocket science. This is unity over division. This is living in a mentality of the RISING TIDES LIFT ALL BOATS. And again let me repeat, UNITY OVER DIVISION.

In closing, i want to share a few strong sentiments that i have...

1. For years i have been hearing about water, can we please just give the water back. I do not understand what the big deal is. Peter Martin donated two acres of land to Maui County for a fire station in March of 2021 that i helped organize. He is generous and wants to make things right. I BELIEVE. My point though is just give the water back. It seems crazy to me that the government does not own it. Especially being one of the wettest places on the planet Earth, how, simply how did we lose water the days of the fire in not one part of the Island but TWO??? Kula literally experienced the same issue of running out of water.
2. On that note and to segway, Hawaii is one of the most strategically placed archipelagos on the Planet. The furthest removed land mass from anyone else in the world. IF Hawaii was sovereign today, I strongly believe with every ounce of my soul that another country would be here immediately to take over. We are a GLOBAL WORLD NOW. There is no going back from that so is it not better to be aligned with the USA? Or what would be better? Can someone please explain to me a better solution when and if Hawaii becomes sovereign, what happens next?
3. Lastly: infrastructure and government. There is a huge disconnect between the local, state, and federal government. As well as I BELIEVE we are living in a very opportunistic county with little or no transparency for over a century now. That needs to stop. The good old boys club and the bullying of our government officials needs to stop. Saying things to the Councilmen and Councilwomen today "we are watching you and how you vote". "We are paying attention to what you are doing". I mean who says that? WHY are things li  
IF you want to serve in government and VOTE then get involved. You know that ANYONE can get into politics or public office as a citizen of the United States of America. Moving forward I expect to see as a west Maui resident those power lines to be buried in Lahaina town. That is number one. And then after Lahaina, we need a five year plan to bury our power lines in Honokowai, Kahana and Napili. As guess what? It is US next up there. If you see the power lines right outside my neighborhood in Kahana it is SO alarming. I am literally just waiting for this to happen to me. His ears were still smoking from a fire ball hitting the back of his head while hosing down his roof. Even more tragically for their situation, this is the SECOND time their house burnt down. in 2018 their house was one of the 22 homes lost that were rebuilt and believe that THIS TIME around, this is on the hands of a disorganized system and government who also could REALLY use some more eyes on the budget.

IF IT IS TRUE that Lahaina generates 40% of the taxable revenue in Hawaii then we need to do more for Lahaina. We need Hui F Rd. fixed. We need sidewalks in Kahana. We need our parks restored and a skate park in Napili. And we REALLY need stoplights down by the old car wash off of Keawe and outside of what i feel is number one with burying the power lines, we NEED THAT bypass extended. You guys are not going to build 400 new homes and then not give me a way to get out when my house burns down because of the faulty power lines that catch fire. I WILL NOT be stuck in a grid lock with my friends and DIE like the innocent victims in Lahaina did. And that is right, THEY ARE THE VICTIMS. Let's not forget those that have perished ESPECIALLY as we restore and bring unity to Lahaina just the way God intended it. As a long time resident of Lahaina who was born and raised here and called Lahaina home for my whole life I am hopeful that our local government will do right by our community and our town. Below are the things I feel are most important for Lahaina to move forward and thrive.

First, I believe the original stream flows need to be restored. People should be able to own the land but NOT the resources. Water should not be private and I urge you all to return the water to Lahaina and the people.

Second, this tragedy unfortunately just amplified the already absurd housing crisis that this state, island and town have faced for decades. We need rent control, a short term rental BAN and legislation that taxes people who do own here and let their homes sit empty or be used for tourists.

By banning or creating a moratorium on short term rentals in West Maui you can very quickly help solve the issue of displaced families by forcing landlords to rent long-term to residents or sell to them vs. continuing to line their pockets renting short term to people on vacation.

Third, I urge you to do MORE thorough testing of the air, ash and water on Lahainaluna where you intend to send kids back in the coming weeks. Although educating our keiki is extremely important their long-term health should supersede that. I keep reading that the air is fine but the ash is dangerous and have seen videos almost weekly since the fire of big ASH dust devils tearing through Lahaina.

Fourth, push to have peoples mortgage payments delayed during the rebuild and allow people to sell if they'd like but ONLY to other Lahaina residents. I'm not sure how people are supposed to afford rent and to rebuild if they are paying a mortgage on a house that is no longer standing.

Fifth, I hope moving forward we do everything in our power to develop an emergency plan that DOES work. I personally don't think the events on August 8th were planned but I can confidently say that mistakes were made on all levels and that cannot ever happen again. When there is an emergency the alarms should sound and then there should be a radio station people can tune in to for updates. Especially if phone and internet services are down.

Sixth, please please please put the power lines underground. Repeating this tragedy would be far more

expensive than just doing what should have been done back in 2018. Fire aside people were blocked from escaping because of downed lines all over Lahaina.

Seventh, require AG lots to actually be AG lots. No more BS mansions w/ a single papaya tree on an acre. AG lots should be for actual ag use that ensure our water is being used for food security and to support this community not to water someones vacation homes massive lawn.

Eighth, Prioritize affordable homes for SALE in West Maui not for rent. The people here deserve the dignity to own a piece of the place they call home and not compete w/ out of state interests.

Just as Hawaii is not Hawaii without Hawaiians. Lahaina is not Lahaina without its people do whatever you can to keep us all here and thriving regardless of the size of our checkbooks.

Honorable County Council Chair and Council Members,

I am Saman Dias, and today I stand before you to share my condolences and join in mourning for the devastating losses our community has suffered. While I personally did not lose my home or life, I feel a profound sense of grief as I believe we have lost a part of our family and community.

In May 2022, I felt a sense of urgency and began reaching out to various authorities, including the Maui Fire Prevention Bureau, Climate Resilience Department, Mayor's office, and the Emergency Management department. My plea was clear - we needed community education, enforcement, and prevention measures to address the looming threat of wildfires.

Unfortunately, my efforts were met with responses indicating a lack of resources to address these concerns.

Despite my persistence, I reached the Mayor's office only to encounter the same refrain - a shortage of resources. My final message to them was a plea: "I am praying we have no fires, and that you will be ready if the fire starts. That time will come. We should be well prepared for that if we are not prepared to do simple prevention."

Tragically, 15 months later, we find ourselves in the aftermath of a devastating fire that has claimed the Lahaina community, with over 1,800 homes lost and more than 100 lives taken. My message today is clear: our government officials have failed us.

The excuse of a lack of resources from the county is no longer acceptable. I urge our government to shift its perspective from "lack of resources" to "how can we collaborate, how can we work together to serve our community." I'd like to highlight several key points:

1. Fire Prevention Plan: We urgently need a comprehensive fire prevention plan, and the community is willing to assist in its execution.
2. Emergency Evacuation Route: The recent article in Civil Beat reveals the importance of the Cane Haul Rd as an escape route during the fire, emphasizing the need to expedite the development of the West Maui Greenway (WMG). This route is vital for the safety of our residents.
3. Underground Utilities: The call for underground power line infrastructure in West Maui aligns perfectly with the goals of the WMG project. It can serve as an avenue to implement underground utilities, enhancing safety and infrastructure resilience.
4. Climate Change Mitigation: The WMG promotes sustainable transportation methods and aligns with Hawaii's goals for reducing carbon emissions and achieving energy independence.
5. Community Benefits: Beyond safety, the WMG offers improved transportation, recreation, and economic development opportunities.
6. Opportunity for Transformation: Let us change our perspective and channel our efforts into resourcefulness, seeking innovative solutions and partnerships. We can transform the tragedy of the Lahaina fire into a catalyst for positive change.

Additional points I'd like to emphasize:

- Safety of our Children: Schools should practice fire evacuation with children, and we need fire evacuation plans with alternative routes. Idea attached - Lahainaluna- Evacuation route from Hawaii Bike Plan 2003

- Partnership with Red Cross: Conduct ongoing surveys to better understand the needs of our people and provide support through collaboration with county and state agencies.
- Employment and Job Training: Proactively consider retraining programs and job placement to support those affected by disasters.
- Lack of Resources and Funding: The constant excuse of resource scarcity is not acceptable. We should encourage collaboration with the community, including volunteers with professional expertise. There are many grant opportunities that are available. We can help. County has declined.

In conclusion, it is crucial that we do not allow years to pass before implementing a comprehensive wildfire prevention plan. I propose forming a committee that includes experienced community leaders to expedite this process. We must enforce regulations regarding dead grass, trees, and address fire hazards posed by items such as junk cars and equipment. Furthermore, a community education campaign is essential, and we can draw upon the resources of organizations like Ready for Wildfire and Hawaii Wildfire Management Organization. Lastly, we should prioritize the West Maui Greenway as an alternative evacuation path, leveraging the resources and expertise within our community.

Thank you for your attention and let us work together to ensure that such a devastating situation never occurs again and that our community becomes a model of resilience, safety, and sustainability.

Thank you for taking the time to hear community testimony after the Lahaina disaster. We need regulations to help limit outside investors or voices. Most of the residents are working class, please make sure that the wealth does not pollute our rebuilding process. This is a great opportunity for us all to make sure the fires never hit our town again. To be clear: this was not a wildfire, it was a man made fire created by overdevelopment. Man can make this better by planning ahead, give the Hawaiians the water so they can teach us about the 'aina.

My experience in Maui has led me to teach keiki on all grade levels K - 12 as a paraprofessional and English as Second Language instructor. While living in Napili for the past 25 years, I have worked at three different schools here in West Maui and would like to submit my testimony on behalf of the keiki and teens of West Maui. Given the trauma they have lived, their stability and the local schools need to come first as we rebuild. The youth need a center to gather, more parks and planning of GREEN areas.

In order to open the schools correctly, we need two access roads so the students are not stranded and trapped in case of fire. This also involves restructuring the roads including the Pali Hwy which is very fragile and falling into the ocean in two spots. Now that our town has burned down, these students need that one road to transport safely to doctors or dentist appointments, or if they need to buy a pair of shoes. West Maui residents have PTSD; please help us manage a safe life while serving our immediate needs. One road guarantees incredible traffic

paralyzation. which only indicates a lack of planning. Now is our time to make it right.

These children have priority over any "development" or tourism. Lahaina has been "pimped out" for too long, now (for the next 6-12 months) the rest of the state can absorb visitors. Give our children roads, safe water, and shade so they can enjoy agriculture and a self sufficient economy. Manage the land with crops & ulu trees. Vacant land will just be another fire threat.

Good afternoon,

First I'd like to offer my sincere condolences to any of you who have lost anyone in the fires. I can't imagine how painful it is to look at Lahaina every day and see total devastation. My heart is with all of you.

I don't live in Maui but have been traveling to your beautiful island for the past 28 years. The scenery speaks for itself but part of what my family loves about Maui are all the friendly, fixed cats that visit us at our hotels and condos. We were still planning our visit in November because we wanted to support local businesses in their time of need but are beginning to have second thoughts.

We'd been hearing stories about the beloved friendly island cats being rescued by the wonderful "caretakers" who care for them. We often get to meet some of them during our visits. These people are like celebrities to us!

What is troubling however are the many reports we're hearing stateside that the same cats we thought were safe (and presumably other animals) are not being rescued the way we had hoped. I'm not sure if you're aware but we've heard reports that your humane society was catching cats in live traps, but if the cat seemed wild, it was to be released right back into the burned out areas, without access to food or water, where it will surely die. And apparently there are as many as 500-700 cats still in there. My husband is a retired fire chief and has told me the horror stories of what those cats are facing. Asbestos poisoning, exposure to toxic chemicals, dehydration, starvation and respiratory failure.

How is it that this is allowed to happen? Why hasn't there been more done to help care for these animals? The place that I called my second home for nearly three decades has failed at caring for the cats of Maui. Feral or not, every animal's life should at least merit respect and good faith efforts to be saved. Until I hear that the humane society is making every effort possible to save as many animals trapped inside the burned down areas, my family can't in good conscience ever call Maui our second home again. Please remedy this.

I would only add that local businesses serving local communities need rent assistance to avoid losing our spaces- or legislature that assists what is conscionable during this time. So far there are no actual 10k grants and our big landlords aren't giving us help. It is in their financial interest to evict some of us based on truly one sided contracts as is. With the level of unemployment and underemployment and the good hearts of the some of the good businesses giving back or paying it forward- making rent, cam and bills seems close to impossible.

I would add that grants for K\_naka and generational non-white business owners should be in place for the future/present. As Haole- I know this is a key for the rightful stewards to remain in their land. Opening a business here is almost exclusively for transplants or non-residents because the costs are astronomical- truthfully they are nonsensical. If real locals don't run the small businesses here- we lose more of the cherished mom and pops and needed influence in the business community. That meeting at the Ritz is a good example of what happens when there is a lack of representation in the business sector. The opinions lean towards those that are only affected in one way by the tragedy. That's not fair.

I am opening a business in Napili Plaza and I know it may not survive this. I also know that the needs of the people are the most important. All businesses are not created equal and residency alone in Lahaina or Hawaii is not indicative of Aloha.

If any business or government entity or organization is not taking into consideration the voice of K\_naka Maoli; I don't think their voice should carry much weight at all.

In addition- I live in an apartment complex in Napili with open units... Lahaina families should be placed here so they can stay in this side. Of course it is excruciatingly overpriced. The complex is an out of state owner- the government can and should do something to put the people over the businesses. We all deserve real neighborhoods with people that truly care about the land and each other. Tourism can't come back in good conscience until the most has been made of what we already have on this side too. That's the minimum.

Please see my testimony below regarding recovery and resilience following the Lahaina wildfire event by category of issue:

#### **PROPERTY / LAND OWNERSHIP**

- Prioritize the needs of our displaced community by advancing legal and legislative action to halt mortgage payments and accrual of interest until rebuilding can begin.

- Provide safe and suitable temporary housing for our displaced 'ohana. Families need stability and children need continuity in schooling. Do NOT force families off the island by failing to address this major need.

#### **FOOD / MENTAL HEALTH / OTHER RESOURCES**

- Provide a centralized, easy-to-find online link hub directing residents to critical resources WIDELY promote this information and use it every time there is a need from here forward.
- Staff up Maui County's 211 information call line to quickly and efficiently answer questions about resources available. Not all residents have access to mobile data or the internet, nor feel comfortable navigating the county's cumbersome website for information.
- Provide transparency about all monies received and how they will be or are intended to be used in the coming months to directly support survivors.

## REBUILDING LAHAINA

- Stop promoting traffic and driving. Envision county-funded shuttles that run every 10 minutes along the new Front Street, giving access to Lahaina town and relieving congestion. This applies no matter how set back from the ocean it may be.
- Encourage alternative transport with bike and walking lanes suitable for small electric scooters and other wheeled equipment.
- Create affordable housing opportunities for Lahaina residents who were previously stuck in the overpriced rental market.
- Build a new, beautiful boat harbor that is adequately maintained and staffed and funded by DLNR fees collected. There was so much corruption and mismanagement in the old one.
- Bury electrical lines in and nearby population centers and upgrade the grid to be smart-controlled when power needs to be shut off.

## SAFETY / EARLY WARNING / EVACUATION

- Create statewide standards and legislative mandates detailing the minimum requirements for disaster early warning and response plans and training that every County must adhere to. Fund these functions and institute checks and balances to ensure each County adheres to the standards.
- Create a policy for new appointees and elected officials to receive immersive training in the escalation of emergencies and how to make official requests to the National Guard, military, and federal government for additional responders and disaster relief.
- Hire emergency management leadership with on-the-ground, life-saving experience, and active-duty training only. No political loopholes for bypassing this requirement. People who have seen action understand the urgency and take seriously their responsibility for saving lives and will use every tool in their arsenal to do so.
- Employ and exercise annually the use of multiple modalities of early warning. This includes grassroots, community-based designees who can go door-to-door when other systems fail, to use of the sirens for all major events, and cellular system redundancy to ensure cellphone alerts are received.
- If possible, pipe ocean water to the fire hydrants so they are not using our precious fresh water.
- Finish the Lahaina bypass to ensure adequate evacuation of residents and visitors. This part of the island can easily be cut off from resources by tsunami, fire, tropical cyclones, and other hazards.
- Maintain equipment, health supplies, food and water in warehouses located strategically across Lahaina and other parts of Maui (South side and Hana), and routinely inspect the equipment and goods.

## TOURISM / SUSTAINABILITY

- Return the control of water to the people. Currently, a few private corporations extract from the watersheds and aquifers, never allowing replenishment, and return nothing to the community (Mahi Pono). Do any of our planning department or policymakers have any idea how much water we have left in the aquifer? Recent decisions about water use are dangerous and unsustainable for all life on this island.
- Immediately reprioritize the use of Maui County's precious freshwater resources to ensure the sustainment of life on the island now and into the future. Extracting all the water from watersheds and aquifers for the entertainment of tourists and lavish landscaping is not sustainable or pono.
- Stimulate a job economy through eco-tourism and conservation of resources. Create a county-sponsored ride-share app/business where residents who participate in giving rides to tourists (reducing congestion on the roads and carbon monoxide emissions) get tax breaks and revenue.
- Create community farming/education programs funded by grants and tourism.
- Heavily invest in water quality and coral restoration jobs along the coastline where injection-pumping of



wastewater has destroyed the Kaanapali ocean ecosystem. Many tourists would like to give back, participate in educational programs, and pay for eco-experiences.

- Favor local sustenance farming over commodity crops (Mahi Pono, A&B). According to the 30-year State plan, the Hawaiian islands were supposed to be food-sustainable and independent of outside suppliers. We have the capacity in Maui to feed all the islands but still, our leadership chooses to import 97% of our food supply. Provide tax breaks and incentives to local farmers and give them water to be successful.

- Ensure sustenance farming is first in line for water use over wasteful hotel and millionaire landscaping uses. This includes the multi-million dollar Montage housing complexes that run water all day to irrigate tropical rainforests in drought-stricken areas. Waterfalls, lazy rivers, and entertainment pools should not be permitted use if our own people are punished for watering their food gardens in their own backyards! Life over luxuries!

My name is Lara Taamu and on 8/8/2023 my two adult sons and myself fled our 1321 Kenui Front St Aps home that had been our home for 20 yrs.

I have many questions, but will focus these questions about the failure of being notified of life threatening danger by radio and text. These basic tools were not effectively executed by the emergency response network. I need to know the answers for my mental health. Our Community deserves to know the degree of negligence thru transparency of their actions. The WORLD is watching how State of Hawaii and County of Maui are treating the PEOPLE, many many comments being made worldwide about how they can not consciously vacation to a place that is dangerous and reckless with the lives of its residents and visitors.

On Sept 19, I asked the Mayor Bissen office and the Gov office the questions. Both offices transferred me to voicemail and I have had no response as of today's date.

My first question is WHY WAS THERE NO EMERGENCY INFORMATION ON THE RADIOS AS WE WATCHED FIRE ON WAINEE AND LAHAINALUNA FROM 2 PM. MANY NEIGHBOURS CALLED 911. I WATCHED THEM FROM MY WINDOW AS I OBSERVED THE FIRE FROM MY BACK LANAI - LOOKING MAUKA TO LAHAINALUNA. I HAVE A SOLAR BATTERY RADIO AND WENT STRAIGHT TO RADIO FOR INFORMATION. NOTHING BUT MUSIC.

4:25 PM WE FLED THE APT WHEN SMOKE WAS COMING INTO THE AIRCON AND SETTING OFF SMOKE DETECTORS IN THE APT. WE SAT IN BUMPER TO BUMPER GRIDLOCK FROM KENUI ST TO MY FINAL DESTINATION, WHALER'S VILLAGE FOR 2 HOURS. THATS A MILE AND HALF AND SHOULD NOT HAVE TAKEN 2 HRS. DURING THIS TIME WE WATCHED LAHAINA BURN IN OUR REAR VIEW MIRRORS AND CONTINUED TO SEARCH THE RADIO FOR INFORMATION.

THE RADIO ONLY PLAYED MUSIC FOR THIS ENTIRE AFTERNOON. THE RADIO SHOULD HAVE BEEN GIVING THE COMMUNITY THE INFORMATION GATHERED FROM 911 CALLS AND POLICE DISPATCH. TO WATCH THE TOWN BURN AND LISTEN TO ONLY MUSIC IS LIKE A TWILIGHT ZONE HORROR SHOW GONE REAL. THIS IS CAUSING ME DISTRESS BECAUSE OF TOTAL LACK OF NEGLIGENCE AND ADDED TO THE FACT SIRENS WERE NOT ALLOWED MAKES FOR VERY DARK AND GRIM CONCLUSIONS.

AGAIN, WHY WAS THERE NO INFORMATION ON THE RADIO 8/8/2023 ABOUT THE LEVEL OF DANGER AND ESCALATING EMERGENCY FOR LIFE AND DEATH. ITS THE RADIO!! IT SHOULD HAVE BEEN NOTIFYING PEOPLE OF SEVERE DANGER. THIS IS CRIMINAL.

MY SECOND QUESTIONS IS ABOUT THE 4:18 EMERGENCY TEXT I RECEIVED. THE TEXT WAS THE ENTIRE LENGTH OF THE FACE OF THE PHONE DESCRIBING THE HAWAIIAN NAMES OF THE AHUPUAA AND THE LAST SENTENCE WAS EVACUATE NOW. I HAD TO READ THRU VERY LONG UNFAMILIAR HAWAIIAN WORDS TO GET TO THE SIMPLE ALERT EVACUATE NOW. IT CAUSED ADDITIONAL STRESS TO FIGURE OUT WHAT HAWAIIAN AHUPUAA WAS BEING DESCRIBED.

ON OAHU I HAVE NOTICED THAT THERE ARE SIGNS THAT SIGNIFY THE HAWAIIAN NAME FOR THAT

AHUPUAA. NOT IN LAHAINA. THERE IS NO WAY THAT THE PUBLIC WAS FAMILIAR WITH THE WORDING OF THE AHUPUAA DESCRIPTION AS SHOWN IN THE EVACUATION TEXT. NOT EFFECTIVE AT ALL AND LIMITS THE ABILITY FOR PEOPLE TO UNDERSTAND WHAT THAT TEXT WAS TRYING TO SAY .... EVACUATE NOW WERE THE LAST TWO WORDS. THOSE SHOULD HAVE BEEN THE FIRST TWO WORDS.

I DO NOT HAVE THAT TEXT AS OF 9/27/2023 BECAUSE ALL MY TEXTS HAVE BEEN REMOVED FROM MY PHONE. MY ASSOCIATES WHO RECIEVED TEXTS FROM ME THAT DAY ALL HAVE THE CONVERSATIONS WE HAD 8/8/23. HOWEVER, IF SOMEONE WAS GIVEN THAT ALERT AT 4:18PM - IT HAS BEEN SCRUBBED FROM ALL OUR PHONES AND I AM DISAPPOINTED I DID NOT TAKE A SCREEN SHOT OF THE ALERT TEXT. I DID NOT THINK ALL TEXTS PERFORMED 8/8/23 WOULD BE REMOVED FROM MY PHONE. WHY IS THIS?

SIMPLE QUESTIONS WHY DURING LIFE AND DEATH SITUATION NO INTEL ON RADIO? Aloha Hon. Councilmembers,

Thank you for opportunity to offer testimony about our concerns as we all works towards the recovery of our beloved Lahaina.

Near-term recovery:

1. There are hundreds of residences in the burn zone at Opukea, Ho'onanea, and Kahoma Village that are still standing and can be a piece of the housing solution if all agencies work together to prioritize returning these areas to safe inhabitability! But that has to be a coordinated effort to make it happen. This includes restoring utilities (sewer, water, power, telecom). This includes prioritizing the work on the water system to re-establish safe water and remediate and remove the safety advisories. But also must include prioritizing the properties needing debris removal in and adjacent to the parcels. Until the debris removal is completed on the adjacent properties, owners can't move forward with necessary remediation of ash, soot, and smoke in the homes because insurance companies will only provide coverage for all the treatments once. Only after this happens can these hundreds of residences become a part of the housing solution moving recovery forward for displaced residents and freeing up additional rental inventory for those who lost homes.

Long-term recovery:

2. Critical evacuation planning and infrastructure is our greatest concern for long term planning the County does because it's a \_safety\_ issue for the most important stakeholders in all of this - the people. We've known for all of our two decades in west Maui that if an emergency ever arose down where we are off of Front Street, that the evacuation would be complicated. We always imagined that the threat would come makai from the ocean. But on that tragic night of Aug. 8th, it came from mauka at us like a freight train. Please ensure all of your committees put a comprehensive and defensible evacuation plan into place for all of the west side, mauka to makai. From our homes, from our schools, from our community gathering places and parks, from the businesses.

3. Harden the utilities infrastructure, bury the power lines (ESPECIALLY through the lens of keeping the evacuation routes clear in any future emergency) and mandate fire-fuel/brush remediation annually across all of

the West Maui hillsides mauka.

4. Medical infrastructure - fast tracking the West Side medical center is beyond overdue for the benefit of all. Our kapuna, keiki, and community all deserve access to high quality healthcare and emergency care that isn't a 45 minute ambulance ride away over in Wailuku.

5. If the 3.2 sea level rise modeling in the SLR-XA is going to prevent rebuilding along the shoreline, then please prioritize securing these lands in perpetuity as shoreline parklands available to all, returning the aina to the people to use.

6. We imagine a Front St. where it's safe to walk without the burden of car traffic end to end, with uninterrupted views makai, with the Moku'ula restored for all of us to learn from.

7. Fast track the Bypass extension and address the urgent need for safer access out to the north around Kahakuloa. We've all known for decades that a narrow one lane road is not adequate emergency infrastructure - please do something about it already!

8. Help the rebuild efforts in Lahaina to become resilient by granting funding, offsets, incentivization, etc. for green infrastructure such as PV power on residential and business structures, green/climate-resilient building materials and methods, etc.

Additional recovery concerns: We'd like to see all-agency coordination to restore access to Mala Ramp for the benefit of the community as soon as possible. As Lahaina community members, we care about getting Mala Ramp open to all again (residents, long time permit holders, those with necessary needs for west side access because of fire losses at the harbor alike). It's frustrating when elected officials refer in public meetings to the "community" as if we all feel the same way about access at Mala Ramp. I respect there are community members with diverse needs, desires, hopes, and opinions about access at Mala Ramp who may feel differently than we do, I hope all are given consideration for diverse views when the County and State are charting paths forward. We care about restoring access for residents. We care about the safety of the nearshore reef from stranded vessels on the moorings, and therefore care about getting them access to launching their support tenders for maintenance. We care about the resiliency of the maritime fleet as employers supporting ~1000 jobs on the west side (between Lahaina Harbor, Mala Ramp, and Kaanapali). There's a need for balance there—of course, but access needs to be restored and allow for recovery and resiliency of all stakeholders needing west side ocean access.

Mahalo and Aloha as you work through these immense challenges. We appreciate your service to the community.

My name is Elise Travis and I am a 44YR. resident of Maui. I am appalled how the animal rescue was handled by MHS. Top animal rescuers came on their own donations, brought all the top equipment for rescue and wanted to offer their services free of charge and work with anyone to help in the fire zone. They were told explicitly by MHS they were not invited and told if they are anywhere near the fire zone they will be arrested. No Aloha, No thanks for wanting to help. Very cold. MHS was adamant about this and these were the top rescuers who were deployed in Ukraine twice last year saving animals. They were treated horribly. We have all the documents to show this. I would like transparency and would like to know how much the rescuers who were allowed to be in charge were pd. From what I heard they have been pd. a lot of money (\$200,000+) Also, they were not allowed to be in contact with the group hired and not allowed to be connected to work with anyone else. So, many lies were spread to keep them out. We need an investigation into this. This group that was denied clearance also had hazmat training and the drones to go in at night and get the job done fast. I am outraged that this was allowed to happen and the way they were treated when all they wanted to do was to help save the cats in the fire zone. No money needed to pay for their services. Also, the group that was contracted by MHS had no fire experience with fire cats along with the people held in charge. They are only trappers and no training to how to deal and trap the fire cats. They had one photo op and left. They did nothing and got pd. a fortune. I would like transparency as to what they were pd. Also, why they spread the lies to turn people against this group. All documented. Also, would like transparency on the donations collected for the Fire Cats and Animals. This money needs to go for them alone. They cannot be put back into the fire zone like MHS is doing. MHS needs to open sanctuary's with the 3+ mil \$ they collected. This money needs to be earmarked for the well being of the firecats. That's what the donations were for. They can't just release them back into the fire zone. Right now, they will be spraying bad chemicals that will kill any cats left in the zone that are suffering and not being saved. We need the top professional rescuers to come in before they do any spraying. The ones that are hired do not know what they are doing. They are not trained to rescue Fire cats. This is a very specific type of training and it needs to be done now! there is no more time to waste. The Colony Cats were all affected by the fires and by law they are required to take care of them also. No food was allowed to be given to The Colony cats when MHS was giving out food. I was told explicitly by one of the volunteers that food was only given out to Pet Owners. By law they were required to also give food for the Colony cats that were in the Fire Zone and affected by the Fires. This was not done also. Subject: Public Testimony Regarding A Comprehensive Recovery and Resiliency Plan for West Maui

My name is John Helly, I am a resident of West Maui for about 22 years. I am a scientist at Scripps Institution of Oceanography and the retired Laboratory Director for Earth and Environmental Science at the Supercomputer Center at the University of California, San Diego. I am also a Board Member on the Maui County Board of Water Supply but offer this testimony as a private citizen.

I would like to make the following six points for the consideration of the Committee.

1. Watershed Management: West Maui needs a watershed management program that implements defensible fire boundaries around the fallowed, privately owned, agricultural lands. The existing programs, that I am aware of, focus on ecological health of watersheds but not on wildfire control per se.
2. Meteorological Data: Wind data is important in predicting fire risk, fire-fighting and post-fire forensic analysis. In the aftermath of the Lahaina fire, I've attempted to organize wind data to support the fire investigation and, so far, find that there isn't any. Meteorological stations are low-cost items that provide invaluable data for fire control and risk mitigation.
3. Emergency Communication Centers: Outside of Lahaina, we were largely unaware of the extent of the disaster for days. People on the mainland and the other side of the island knew more than we did as we learned through occasional cell-service from a few high spots. Emergency communications centers should be developed within the west-side communities and provisioned with Starlink stations, HF/VHF/UHF radios and antennas, and emergency services scanners with emergency power sources. Starlink stations popped up spontaneously in a variety of locations so it is already proven important. The County should institutionalize this capability and pre-position the equipment and operational and maintenance responsibility and publicize it.
4. Evacuation Routes and Staging Sites: Already an obvious topic due to what happened on Front Street and others. Highway 30 and Lower Honoapiilani are the only routes. During the Kaanapali fire, we had to evacuate from the Hillside and the stretch on 30 between the Lower Honoapiilani Road and Kapalua Airport are perfect setups for the evacuation gridlock that trapped people in Lahaina. There should be firebreaks along the highway and escape routes to fire-safe staging areas mauka of the highway to avoid gridlock to allow for controlled traffic flow.
5. Utility Infrastructure Hardening: The utility infrastructure on Kaanapali Hillside is dangerous. The dried and fragile telephone poles used to support the cables going up Puukolii Road, for example, appear ready to collapse and fall on the passing traffic without any disaster as a cause. This obviously all needs to be hardened and made fire resistant.
6. West-side Medical Center: The West Side medical center should be speedily developed for the obvious

reasons. It could also provide a staging area for evacuation with a fire-safe boundary.

I'm available to elaborate further on any of these topics and to provide whatever assistance I can.

Aloha Maui County Council,

As someone who has worked animal welfare on Maui for the past decade my vision for rebuilding is bringing the local animal rescue community together during this unprecedented time. Maui Humane Society (MHS) stated in a press article 2 days ago that they are estimating still 500 live animals inside the burn zone waiting for rescue, but

yet they are only allowing a couple trappers from the mainland in to help. This is despite having credentialed professional animal search and rescue groups like Hawai'i Animal Kuleana Alliance (HAKA) on island sitting standby ready to assist.

Instead, at the beginning of September a New York based group called Neighborhood Cats (NC) was tasked by MHS to run the trapping/rescuing in Lahaina Town. NC is a Trap Neuter Release (TNR) group consisting of just a couple people that have no experience in disaster rescue like HAKA does. It's become clear very quickly that NC is not equipped to run the rescue side of things. For example, they only had one third the amount of feeding stations established that the professionals (AIM that MHS had brought in last month) told them they needed based on live animal sightings. It's completely unacceptable that AIM gave their assessment/recommendations and then NC didn't follow up until the next fire expert got into the field almost 2 weeks later and realized there was not even close to enough food/water to meet the huge need. That fire rescue expert also gave recommendations that have since been ignored. NC has proven to not be transparent with the community or even a team player as in the 5 years since the husband/wife two-person-team moved here they denied assisting the two main TNR groups on island.

It has been stated that after the county is done escorting Lahaina homeowners back to their properties that Soiltac will be sprayed and demolition will begin in these areas. There is a timeline of 3 weeks before FEMA starts spraying the Soiltac and begins demolition. This is an urgent situation and the local animal rescue community is reaching out again to offer our help because we don't feel it will be a safe environment for any cats once this process begins. The cats that survived the fire need to be removed from the burn zone immediately and their ohanas given a chance to find them/reunite.

What it comes down to is that locals with disaster rescue credentials are willing and wanting to help with the fire animal rescue operations, but are being denied when they should be the ones leading these recovery efforts! We are begging the county to allow HAKA in who will continue working with the local rescue community where transparency and true team work can begin as we move forward together with these long term rescue efforts.

Our process yields a combustible gas and inert ash. IEC will temporarily store the inert ash awaiting interment. The decisions regarding interment will rest in the hands of those most connected to the Town of Lahaina. The IEC process is essentially modular and portable. IEC will locate its hardware at a site suitable for a temporary project. The total area needed is 2-3 acres. IEC will place at the site material preparation equipment, thermal reaction hardware and combustible gas (the gas produced by the IEC thermal reaction) processing equipment. IEC has targeted a timeline for completion of the conversion process of less than 12 months. The operation of the conversion process will be conducted by a local company already identified by IEC. The local company will train and employ Lahaina and Maui persons to complete the conversion process. The IEC conversion process is demonstrably carbon neutral if not carbon negative. The process is fully compliant with prevailing Federal and State environmental statutes and regulations. For instance, no particulate matter escapes IEC's controlled process. Additionally, all organic compounds are converted to an environmentally safe and benign state. As noted above, throughout the entire conversion process IEC will seek the guidance of persons connected to the Town of Lahaina to ensure the preservation of the dignity of the remains. IEC fully recognizes that the conversion of the remains is not an industrial project. The conversion of Lahaina and most importantly the unrecoverable victims is the final process of interment. The preservation of dignity is the first and continual principle. Aloha Maui County Council,

I support the following policies for Lahaina's recovery and future resilience.

1. Ten year moratorium on ALL new vacation, short-term, transient rental permits, homes, and units for all of Maui County.
2. Ten year moratorium on ALL permits, buildings, and construction for hotels, resorts, condos, and any accommodation used for short-term/transient visitors and/or tourists for all of Maui County.
3. Additional county tax incentives and rebates for owners who rent their home or apartment/condo to long-term (12 months or longer) Hawaii resident tenants.
4. Increase county tax rates on ALL short-term, transient vacation rental units and homes.
5. Ten year ban on all cruise ships for all of West Maui.
6. Strict monitoring and enforcement of county (and state) commercial activity permit regulations for businesses that operate on public land, beaches, and near shore waters (surf schools, kayak tours, photography, wedding ceremonies, etc.).
7. Establish an additional county TAT for all transient accommodation that will be used for Maui County infrastructure modernization and maintenance.
8. Increased fines and tax penalties for land and/or home owners on land zoned for agriculture who are not operating agriculture business.

Maui's housing shortage is a direct result of the county and state's approval of approximately 12,000+ short-term vacation rental units while ignoring the housing needs of residents. The county and state allowed Maui's development to outpace our island's infrastructure for decades. Before August 8, 2023, the daily visitor population was approximately 40,000 to 70,000 tourists with approximately 20,000 rental cars on island, in addition to the

resident population of 165,000. Stop building and approving short-term accommodation that overburdens limited island resources, outdated infrastructure, medical facilities, and emergency personnel.

Lahaina residents lost family and friends, homes, and businesses because the state and county prioritized tourism industry profits over the needs of working class residents for decades. Water shortages, chronic drought conditions, shoreline erosion, annual wildfires, outdated sewage treatment/infrastructure, crumbling electric grid, emergency personnel shortages, and inadequate medical facility infrastructure are all issues that must be addressed now to create a resilient island and resilient island economy. The catastrophic fires on August 8 were the direct result of the county's status quo policies that ignored residents' needs while catering to tourism, real estate, and land development lobbyists. Maui County has employee shortages in all major employment sectors including the following; medical, education, skilled trades, emergency first responders, state/county parks and recreation enforcement, retail, and service (including resorts and restaurants). Lahaina/Maui doesn't need more tourist accommodation or luxury vacation homes. Maui doesn't need more tourism sector jobs. We have enough already.

Maui needs affordable long-term housing and modern infrastructure to support the development that was allowed to outpace our island's finite resources.

Aloha Chair Nohelani U'u-Hodgins, Vice-Chair Tamara Paltin, & Committee Members,

As we prepare for the GREAT meeting at the Westin on 9/27 in West Maui, I was hoping to get some comments from you all..

I understand that this meeting is to "invite thoughts regarding Resolution 23-194" however, I don't think majority have or will have time to read this 10-page document (especially when people still need to read the 12-page Bill 86; and attend the Special Meeting on Monday 9/25). As I share and encourage my sphere to attend + speak to have their voice heard, I found it important to ask this GREAT Committee the following questions:

- \_ What specifically are we asking of the West Maui Community to speak on and have their voices heard? (Pretend no one knows about Reso 23-194).
- \_ Are we asking the people to speak on what went wrong 8/8, so these failures are on the record?

- \_ Are we asking the people to speak to potential solutions/prevention ideas?
- \_ Are we asking the people to speak on how they think Lahaina should be rebuilt?
- \_ Are we asking the people to speak on anything not mentioned?

I attended the GREAT Committee meeting on Monday and intended to testify but was pulled away before I could do so. The reality is the majority of West Maui fire-survivors have not been able to attend the various meetings even on-line for countless reasons. They are experiencing high stress, literally living week-to-week in hotels with no long-term option available and a mere 3-days notice of location changes so the hotels can accommodate TOURISTS coming 10/8, all while trying to manage PREMATURE vital deadlines for XYZ things that force them into cattle-call lines etc. Additionally, there have still been no childcare solutions or schooling for majority Westside keiki, which has been a frustrating ongoing cry to the DOE + State Reps that have fell on deaf ears.

Furthermore, and staying on point with the GREAT Committee, I have to ask if the Mayor collaborates with the County Council &/or any of the Committees, including GREAT or if he just does his own thing? I'm specifically asking this because of the recent announcement on September 19th on the County of Maui Social Media platforms spotlighting the new "Lahaina Advisory Team". I would have expected this to come AFTER the West Maui meeting, which is why I was so surprised and genuinely curious about communication channels (or lack thereof). Or perhaps I'm just confused as to what the GREAT Committee Meeting is actually for on 9/27.

Mahalo nui for your time and for clearly having compassion on Lahaina – I appreciate the Council's decision to defer Bill 86 and to host this GREAT Committee Meeting on the Westside. And I thank you in advance for expanding on the questions listed above. \_

PS: If anyone can let me know why Reso 23-201 was deferred and what Committee it defers to, that would be greatly appreciated! I felt the number of testifiers supporting the Council to urge the DOH to continue the AMR contract was clear, so I was confused why it was deferred at all and want to keep up with it &/or help advocate my sphere to send in (more) written testimonies.

I will say, I had to scan that semi public notice in the online Mauinow.com article, just to find day, time, location and room. I never saw such a piecemeal public announcement, it followed no standard of protocol call. I have been a former County Planner and private consultant since 2000. Mala Boat Ramp

Aloha

This email is intended for the Maui Emergency Management Administration (MEMA), DLNR, MPD and the US Coast Guard.

Hope this email finds you all well. I know the County is working hard with the Re-Entry to Lahaina. I am following up on a particular part of the Re-Entry plan which is the opening of Mala Ramp (Zone 6A).

We believe it is time to move forward with the opening as the community needs a safe access for gathering, transportation and recreation on the West Side.

Here is a list of government concerns we have heard that we from the public understand and believe these answers can help the government with the decision to open up Mala:

-In accordance with the MauiRecovers.org zoning map that shows the opening of zone 5B (Lahaina Cannery Mall), vehicle access thru zone 5B is achievable to Zone 6A, which encompasses the Mala Wharf area, all its parking and even part of the beach at Mala.

-It is well known that Kahoma Village residences are living in their homes and vehicle access for them to go to & from Kahoma Village has little to no safety concerns from the fires as that access drives right thru zone 6A to get to zone 5B.

-Barricades would need to be relocated to maintain the secure access points on both the South & North side of Front St of zone 6A. This seems achievable by relocating the current National Guard barricade at 5B at the back end of the Cannery that leads to front Street further South to where Front Street meets the road to Mala so anyone going to Mala Wharf cannot proceed anywhere else except to Mala. Additionally, continue to restrict access to only residences in Kahoma Village to their home.

-We know of several boaters who have now used Mala with special permission from the USCG. There appears to be no navigable hazards for the USCG or DLNR to restrict water access to Mala.

-The rinse water spigots and bathrooms may or may not be working, but these amenities is not critical elements for the operation of the ramp at this time. These amenities in the past were shut off/closed and it did not close use of the boat ramp or beach. This should not be a reason for holding up access to Mala.

-Use of Mala has always been an issue with respect to the limited parking. Tourist on island are limited rn so this

issue may be less of an issue especially if we open it up now. But again, this should not be a reason for holding up access to Mala.

Trailer Boat community members have reached to me and are requesting for updates on the timing of the ramp opening. By the eyes of the public, opening up zone 6A should be a relatively easy decision for all the entities involved. Please Maui County, DLNR, MPD, and Coast Guard give what I say some consideration and prioritize the opening of zone 6A. It would be a huge win for the community, not just the boaters and I think you guys could use any wins you can get with the way this response has been going.
