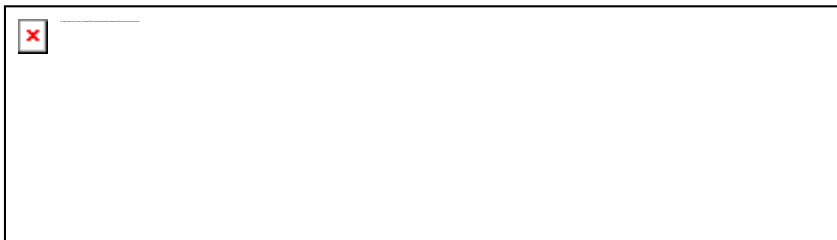
Maui's residents need this development. Single people and small families can both benefit.
