

***KULA AGRICULTURAL PARK COMMITTEE (9 Members)**

Enabling Legislation: Sections 22.04A.070 and 2.40.180, Maui County Code. Ordinance 4336 (Bill 64 (2016)), shall consist of 9 members of the following representation, *if reasonably possible*: 1-Agriculture Lending or Banking Community; 1-Maui County Farm Bureau; 1-Agricultural Trade Organization; 1-Tenant of the Kula Agricultural Park; 1-College of Tropical Agriculture and Human Resources, University of Hawaii at Manoa (CTAHR); 1-Office of the Mayor; 1-Councilmember; 2-General Public. No more than three committee members may hold a financial interest in a lot within the Kula Agricultural Park.
