This is in response to your letter dated August 2, 2018 requesting information on the contract between the County of Maui and Group 70 International for work related to the Molokai Athletic Complex for the Department of Parks and Recreation. Please find our responses to your question and information inquiry below;

1. The Contract Summary report dates July 30, 2018 indicates the contract was disencumbered as of June 29, 2018. Explain why the contract was disencumbered and who authorized the contract to be disencumbered.

Response: The contract in question, C6037, was included on our annual list of contracts that was circulated to various departments of the County for a decision on whether or not to disencumber. However, the contract was erroneously included on the list for Public Works instead of on the list for Parks. Public Works did not indicate to keep the contract open and it was disencumbered. Now that the mistake has come to light the contract has been re-opened and Parks has been notified. We plan to include additional language in our annual contract dis-encumbrance memo

that asks departments to notify Finance should they see a contract listed under their department that is not their responsibility.

2. Provide a list of all encumbrances or expenditures, if any, related to the Molokai Athletic Complex.

Response: Please see attached. Because the Molokai Athletic Complex project is funded by a State grant, the County does not record the actual expenditures on its books. The State records the expenditures and pays the Contractor/Vendor directly and sends the County copies of the expenditure checks (attached). The final process is that the State will notify the County when the contract is fully paid, we then disencumber the contract in IFAS.
